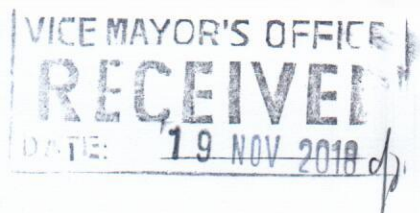

**RESOLUTION NO. 2018-279**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY  
MAYOR RICHARD I. GOMEZ TO ENTER INTO AND  
SIGN A VILLAGE-BASED ARTIFICIAL INSEMINATION  
TECHNICIAN (VBAIT) CONTRACT, FOR AND IN  
BEHALF OF THE LOCAL GOVERNMENT UNIT OF  
ORMOC CITY WITH MR. HIENRICH O. ZALAMEDA.**

WHEREAS, the 14<sup>TH</sup> Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on October 24, 2018 for consideration of the request of Joseph C. Cortes DVM, City Veterinarian, for the issuance of a Resolution granting authority to the City Mayor to sign a Contract to be entered into by and between the Local Government Unit of Ormoc City (LGU-ORMOC) and Hienrich O. Zalameda, for the Village-Based Artificial Insemination Technician (VBAIT) Contract, a copy of the final Contract is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Philippine Carabao Center (PCC) was established by the Philippine Government by virtue of Republic Act No. 7307, otherwise known as the Philippine Carabao Act of 1992, wherein one of PCC's function is to conserve, propagate and promote the Philippine Carabao as a source of draft animal power, milk, meat and hide;



WHEREAS, in order to accelerate the development and improvement of the Philippine Carabao for meat and milk production, both parties hereto have agreed to collaborate to promote and undertake the various programs related to the development of the Carabao Industry and help improve the standard of living in rural areas pursuant to the provision of Republic Act 7307 and the Local Government Code of 1991 (RA 7160);

WHEREAS, both hereto recognized that one of the most practical ways of accelerating the improvement of the Philippine Carabao is through crossbreeding using Artificial Insemination (AI) by trained village-based AI technicians;

WHEREAS, the subject of the VBAIT Contract was to engage the services of Mr. Hienrich O. Zalameda as village-based AI technician which shall take effect on the date of signing of all parties concerned;

WHEREAS, in a communication dated October 01, 2018, City Veterinarian, Dr. Joseph C. Cortes, endorsed the VBAIT Contract with Mr. Hienrich O. Zalameda to City Mayor Richard I. Gomez requesting further that a Sangguniang Panlungsod Resolution be passed authorizing the City Mayor to sign the same, a copy of the letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, Mr. Hienrich O. Zalameda has been given a Certificate by the Philippine Carabao Center for completing successfully the Basic Training Course on Artificial Insemination and Pregnancy Diagnosis on Large Ruminants last October 15, 2018 to November 09, 2018 at Ubay Stock Farm Lomangog, Ubay, Bohol, a copy of the certificate is hereto attached as Annex "C" and made an integral part hereof;

WHEREAS, the services of the village-based technician, Mr. Hienrich O. Zalameda, is subject to the terms and conditions set forth in the contract;

WHEREAS, after review of the VBAIT Contract by the Assistant City Legal Officer of the City, Atty. Jesus Manuel A. Horca III, he finds it not contrary to law, morals, good customs, public policy and public order recommending that a Sangguniang Panlungsod Resolution be secured for the Authority of the Mayor to sign the same;

WHEREAS, upon close and thorough review, this Sanggunian finds the aforementioned request by the City Mayor advantageous and for the best interest of the City and its inhabitants;

NOW THEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances and Member, Committee on Agriculture, Fisheries and Agrarian Reform, severally seconded by SP Members Vincent L. Rama, Esteban V. Laurente, Jasper C. Yerro, Lea Doris C. Villar and John Eulalio Nepomuceno O. Aparis II; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A VILLAGE-BASED ARTIFICIAL INSEMINATION TECHNICIAN (VBAIT) CONTRACT, FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY WITH MR. HIENRICH O. ZALAMEDA;



## VBAIT CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This Contract entered into by and among:

The City of Ormoc, with principal office at New Ormoc City Hall, Aunubing St. Brgy. Cogon, Ormoc City represented herein by its City Mayor, **Hon. RICHARD I. GOMEZ** hereinafter referred to as LGU; and

**Mr. HIENRICH O. ZALAMEDA**, with address at Brgy. Lao, Ormoc City hereinafter referred to as **Village-based Artificial Insemination Technician (VBAIT)**.

**WHEREAS**, the PCC was established by the Philippine Government by virtue of Republic Act No. 7307, an act creating the Philippine Carabao Center to conserve, propagate and promote the Philippine Carabao as a source of draft animal power, milk, meat and hide;

**WHEREAS**, the LGU and the Philippine Carabao Center recognize the importance of cooperative effort in pursuing development objectives pursuant to the provisions of Republic Act 7307 and the Local Government Code of 1991;

**WHEREAS**, in order to accelerate the development and improvement of the Philippine Carabao for meat and milk production, both parties hereto have agreed to collaborate to promote and undertake the various programs related to the development of the Carabao Industry and help improve the standard of living in rural areas;

**WHEREAS**, both hereto recognize that one of the most practical ways of accelerating the improvement of the Philippine Carabao is through crossbreeding using Artificial Insemination by trained village-based AI technicians;

**NOW, THEREFORE**, for and in consideration of the above premises and their mutual consent hereinafter set forth, all parties have mutually agreed stipulated as follows:

### ARTICLE I. RESPONSIBILITIES OF LGU

The LGU shall:

1. Recommend the nominated Village-based technician in AI training;
2. Act as the guarantor of the faithful performance of the Village-based A.I. Technician through the execution of a contract;
3. Supervise and provide assistance to the Village-based A.I. Technician in implementing the genetic improvement program;

4. Monitor the output of the Village-based A.I. Technician and collect report for submission to the Provincial A.I. Coordinator;
5. Promote the service of the Village-based A.I. Technician in the community and empower to become self-reliant and oblige to actively participate in the planning, monitoring, evaluation and documentation of project activities.

#### **ARTICLE II. RESPONSIBILITIES OF VBAIT**

1. Conduct pregnancy diagnosis, artificial insemination, and monitor animals inseminated, impregnated, and calves production at the villages of coverage;
2. Prepare and provide reports to PCC/DA/LGU such as; annual inventory of carabaos in covered area(s), number of animals inseminated, impregnated, calves produce and frozen semen utilization;
3. Properly maintain and handle the frozen semen, AI tanks and supplies and immediately report to PCC and LGU any loss or damages on the equipment;
4. Pay at cost the liquid nitrogen, frozen semen and other AI supplies obtained from PCC after 2 years of receiving it free;
5. Reimburse the training expenses incurred by PCC amounting to PHP 30,000.00 to cover training cost and others in the event that the trained village-based technician could not perform his stipulated responsibilities within two(2) years;
6. Voluntarily surrender the loaned AI equipment to PCC in the event that of the termination these contract or at the end of the project;

#### **ARTICLE III. PERIOD OF AGREEMENT**

This agreement shall take effect on the date of signing of all parties concerned, will be valid for a period of five(5) years, and can be extended as agreed upon by all parties involved.

No party shall terminate each commitment to undertake such project within the period of five (5) years. However, if the VBAIT fails to faithfully perform his tasks pursuant to this contract as determined by the City Veterinary Office (CVO) the LGU may pre-terminate this contract.

#### **ARTICLE IV. LIABILITY CLAUSE**

The LGU shall not be liable for any claims of losses, damages, injuries, harm, death suffered by third persons and or properties resulting from, during and in the course of this
