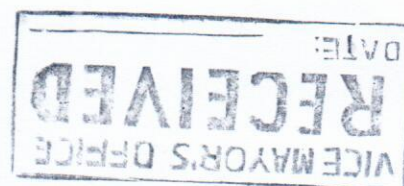
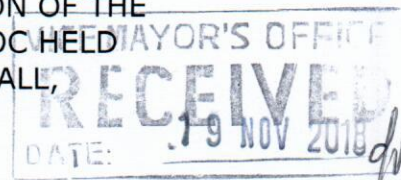

RESOLUTION NO. 2018-280

A RESOLUTION MOST EARNESTLY REQUESTING THE NATIONAL GOVERNMENT THROUGH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) TO TRANSFER WITHOUT COST THE OWNERSHIP OF A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 5099, INCLUDING THE BUILDING CONSTRUCTED THEREIN, TO THE LOCAL GOVERNMENT UNIT OF ORMOC CITY.

WHEREAS, this august Body was in receipt of an endorsement dated October 18, 2018 from the Office of the City Mayor requesting for the issuance of a Resolution requesting the National Government through the Department of Information and Communications Technology (DICT) to transfer without cost to the Local Government Unit of Ormoc City (LGU-ORMOC) a parcel of land covered by Transfer Certificate of Title (TCT) No. 5099, to include the building constructed therein;

WHEREAS, LGU-ORMOC plans to construct a Four-storey Archive and Library Building at the old National Telecommunication (NTC) Building located at the subject parcel of land;

WHEREAS, the old NTC Building is now temporarily occupied by the Eastern Visayas State University (EVSU) pursuant to Sangguniang Panlungsod Resolution No. 2002-123 dated May 16, 2002, a copy of said resolution is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, in a letter dated June 11, 2018, from Engr. Raoul E. Cam, City Planning & Development Coordinator, addressed to former City Legal Officer, Atty. Jasper M. Lucero, Engr. Cam specified that based on available documents the proposed project site under TCT No. 5099 is owned by the National Government, a copy of said letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, LGU-ORMOC plan cannot be implemented while the subject parcel of land is in the name of the National Government;

WHEREAS, as per letter dated October 08, 2018, DICT has not undertaken repairs or improvement on the aforementioned building for the past 30 years, a copy of said letter is hereto attached as Annex "C" and made an integral part hereof;

WHEREAS, upon close and thorough review, this Sanggunian finds that the issuance of the aforementioned Resolution is advantageous and for the best interest of the City, therefore deserves an affirmative action and support;

WHEREFORE, on motion of SP Member Vincent L. Rama, Member, Committee on Ways and Means, Public Properties, and Economic Enterprise, severally seconded by SP Members Gregorio G. Yrastorza III, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Esteban V. Laurente and Jasper C. Yerro; be it

Furthermore, a copy of the resolution was furnished to our Office but same was damaged/washed out during the onslaught of Tropical Storm Yolanda in November of 2013.

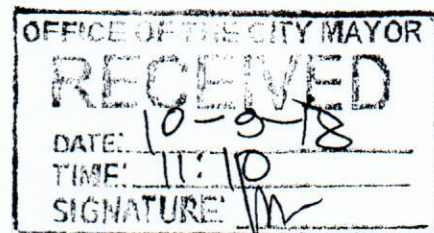

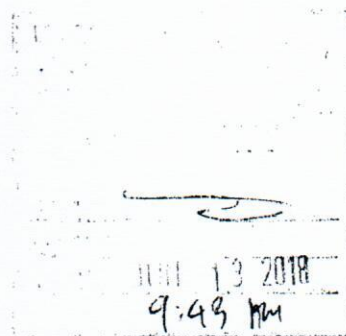
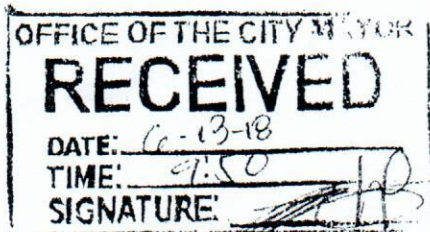

BUILDING INCLUDING THE LOT LOCATED ACROSS THE NEW ORMOC
CITY NATIONAL HIGH SCHOOL, ORMOC CITY, TO THE
ADMINISTRATION OF LEYTE INSTITUTE OF TECHNOLOGY,
TACLOBAN CITY, TO BE USED AS CLASSROOMS OF ITS
SATELLITE CAMPUS IN ORMOC CITY.

WHEREAS, this august Body is in receipt of Resolution NO. 03 s.
2002 from the Parents Teachers and Community Association (PTCA) of LIT
Satellite School, Ormoc City, entitled: "A RESOLUTION EARNESTLY
REQUESTING THE CITY GOVERNMENT OF ORMOC TO IMMEDIATELY TAKE ACTION ON
THE TRANSFER OF ENTITY WITHOUT COST (AN OLD ABANDONED DOTC BUILDING AND
LOT IN FRONT OF THE NEW ORMOC CITY NATIONAL HIGH SCHOOL (NOCNHS) ORMOC
CITY, INCLUDING MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) IN FAVOR
OF THE LEYTE INSTITUTE OF TECHNOLOGY (LIT) MAIN OFFICE, TACLOBAN CITY";

WHEREAS, said abandoned DOTC building came to exist by virtue of
Resolution NO. 78 dated 05 June 1975 of the Seventh Municipal Board of
Ormoc City, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
TO EXECUTE A COMMON DEED OF DONATION TO THE DEPARTMENT OF AGRARIAN
REFORM, THE BOARD OF TRANSPORTATION, THE BUREAU OF POSTS, AND THE
NATIONAL GRAINS AUTHORITY OVER PORTIONS OF LOT NO. 2213 AT THE
GOVERNMENT CENTER SITE, WITH A PROVISION THAT THE SAME BE RETURNED TO
THE CITY GOVERNMENT IF NO LONGER NEEDED";

WHEREAS, the donation extended to the Board of Transportation (now Department of Transportation and Communication) is subject to the condition that if the lot donated is no longer needed by the donee, the same shall be immediately returned to the City Government;

WHEREAS, it is of common knowledge that the lot donated and the building erected thereon is no longer used by DOTC for more than 10 years already, especially that it has a new building constructed at Hermosilla Drive, Ormoc City;

WHEREAS, this august Body believes that said request is meritorious and beneficial, hence, same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councillor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, jointly seconded by City Councillors Demosthenes F. Tugonon & Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF TRANSPORTATION AND COMMUNICATION THROUGH THE REGIONAL DIRECTOR, REGIONAL OFFICE NO. VIII, TACLOBAN CITY, THE TRANSFER WITHOUT COST OF THE OLD AND UNUSED DOTC BUILDING INCLUDING THE LOT LOCATED ACROSS THE NEW ORMOC CITY NATIONAL HIGH SCHOOL, ORMOC CITY, TO THE ADMINISTRATION OF LEYTE INSTITUTE OF TECHNOLOGY, TACLOBAN CITY, TO BE USED AS CLASSROOMS OF ITS SATELLITE CAMPUS IN ORMOC CITY;
