RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE DEED OF USUFRUCT TO BE ENTERED INTO BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC) AND THE ORMOC CITY JACKFRUIT PRODUCERS ASSOCIATION (OCJPA) FOR THE BENEFICIAL USE OF A TWO THOUSAND SQUARE METER (2,000 SQ. M.) PARCEL OF LAND LOCATED IN BRGY. MACABUG DEMO SITE.

WHEREAS, the 14^{TH} Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on October 05, 2018 for the issuance of a Resolution granting authority to the City Mayor to sign the attached Deed of Usufruct to be entered into by and between the Local Government Unit of Ormoc City (LGU-ORMOC) and the Ormoc City Jackfruit Producers Association (OCJPA) for the beneficial use of a Two Thousand square meter (2,000 sq. m.) parcel of land located in Brgy. Macabug Demo Site, a copy of the final Deed of Usufruct is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the LGU-ORMOC is the lawful owner of a parcel of land located at Brgy. Macabug, Ormoc City designated as Lot No. 11476 containing an area of 3.3 hectares more or less, and bounded on the NW by Lot. No. 3528-C, on the SW by Lot No. 3533, on the SE by Lot No. 11477, and on the NE by Lot No. 3535;

WHEREAS, the LGU-ORMOC warrants that the subject property is free from any and all liens and encumbrances;

WHEREAS, the OCJPA is in need of land as a site upon which to establish its Jackfruit Consolidation and Depulping Center(the Project) under the Philippine Rural Development Program(PRDP) funding of the Department of Agriculture(DA);

WHEREAS, the LGU-ORMOC acknowledges said need of the OCJPA and herein agrees to assist in the implementation of the Project;

WHEREAS, the LGU-ORMOC, for and in consideration of public service, allows the OCJPA to be a usufructuary and use a Two Thousand Square Meter (2,000 sq. m.) portion of the aforementioned parcel of land for a period of thirty (30) years;

WHEREAS, both parties have agreed that the activities allowed in the project site shall consist of consolidation, depulping and trading of jackfruit products;

WHEREAS, the City Legal Officer of the City, Atty. Jasper M. Lucero, after review of the draft Deed of Usufruct and rendering minor amendments thereto to aid in clarity and to simplify the terms and conditions of the deed as well as the obligations of the parties, he finds the substance of the same to be in order and not contrary to law, morals and public policy recommending that a Sangguniang Panlungsod Resolution be secured for the authority of the City Mayor to sign the Deed of Usufruct, a copy of the letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, upon close and thorough review, this Sanggunian finds the aforementioned request by the City Mayor advantageous and for the best interest of the City and its inhabitants therefore meriting this august Body's full support and favorable action;

NOW THEREFORE, on joint motion of SP Member Tomas R. Serafica, Chairman, Committee on Agriculture, Fisheries and Agrarian Reform and SP Member Nolito M. Quilang, Vice-Chairman, Committee on Laws and Ordinances, jointly seconded by SP Members Gregorio G. Yrastorza III and Esteban V. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE DEED OF USUFRUCT TO BE ENTERED INTO BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC) AND THE ORMOC CITY JACKFRUIT PRODUCERS ASSOCIATION (OCJPA) FOR THE BENEFICIAL USE OF A TWO THOUSAND SQUARE METER (2,000 SQ. M.) PARCEL OF LAND LOCATED IN BRGY. MACABUG DEMO SITE;

DEED OF USUFRUCT

KNOW ALL MEN BY THESE PRESENTS:

This Deed of Usufruct is entered into by and between:

The LOCAL GOVERNMENT UNIT OF ORMOC CITY, a municipal corporation duly existing by and under the laws of the Republic of the Philippines, herein represented by the City Mayor, RICHARD I. GOMEZ, MBA, as authorized per Sangguniang Panlungsod Resolution No. _____, hereinafter referred to as the "OWNER".

The ORMOC CITY JACKFRUIT PRODUCERS ASSOCIATION (OCJPA), a farmer association of Ormoc City, with office address at Brgy. Valencia, Ormoc City, Leyte, Philippines, represented herein by the Association President DR. AMANDO P. APODERADO, hereinafter referred to as the "USUFRUCTUARY"

WITNESSETH

WHEREAS, the LGU ORMOC is the lawful owner of a parcel of land located at Brgy. Macabug, Ormoc City designated as Lot No. 11476 containing an area of 3.3 hectares more or less, and bounded on the NW by Lot. No. 3528-C, on the SW by Lot No. 3533, on the SE by Lot No. 11477, and on the NE by Lot No. 3535.

WHEREAS, the OWNER warrants that the subject property is free from any and all liens and encumbrances;

WHEREAS, the USUFRUCTUARY is in need of land as site for its Jackfruit Consolidation and Depulping Center (the Project) under the Philippine Rural Development Program(PRDP) funding of the Department of Agriculture(DA);

WHEREAS, the OWNER acknowledges said need of the USUFRUCTUARY and herein agrees to assist in the implementation of the Project;

NOW THEREFORE, the PARTIES hereby agree as follows;

1. GENERAL AGREEMENT

- The OWNER, for and in consideration of public service, do hereby allows the USUFRUCTUARY the USE of a Two Thousand Square (2,000) Meter portion of the aforementioned parcel of land.
- The OWNER reserves unto itself the full ownership of said property, and the USUFRUCTUARY acquires only the rights of possession, use, enjoyment, and management of the property to the extent allowed under relevant laws.
- 3. The term of the usufruct is for a period of thirty (30) years, as required by the PRDP, renewable upon agreement by both parties.

- Any and all improvements introduced on the land, including the Project itself, shall become the property of the OWNER upon expiration of the term of the usufruct.
- 5. The usufruct is automatically terminated by:
 - Termination of the project by the USUFRUCTUARY before the agreed period;
 - b. Termination of the project for any cause other than the actions/intent of the USUFRUCTUARY:
 - Force majeure or any fortuitous event that results in the total loss of the Project;
 - Dissolution or any event that severely disrupts the organizational integrity and normal operations of the USUFRUCTUARY and
 - e. Violation of the terms of the usufruct by the USUFRUCTUARY.

II. OBLIGATION OF THE USUFRUCTUARY:

- The USUFRUCTUARY shall care for the property with the due diligence of a good father of a family.
- The USUFRUCTUARY shall introduce such improvements on the property as may be necessary to the Project or incidental thereto.
- The USUFRUCTUARY shall neither use nor permit the use of the property for purposes or activities not within the usual activities (consolidation, depulping and trading) of the Project
- The USUFRUCTUARY shall neither use nor permit the use of the property for any purpose that is contrary to existing laws.
- 5. The USUFRUCTUARY shall neither use nor permit the use of the property as a residence for any of its members or any person.
- The USUFRUCTUARY shall defray all taxes and any other charges imposed on the property during the term of the usufruct.
- The USUFRUCTUARY shall shoulder all charges for water consumption, electricity, telephone, and other utility services in the premises, as well as for the repairs in the utility system.

III. OBLIGATIONS OF THE OWNER

- The OWNER shall warrant that right-of-way and other easements necessary to the beneficial use of the property are properly settled.
- The OWNER shall not sell, mortgage or otherwise encumber the property during the existence of the usufruct.
- The OWNER warrants that the usufruct shall be enforceable against it regardless of any changes in administration during the term of the usufruct.
