# RESOLUTION NO. 2018-297

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY FOR AND ON **BEHALF** OF GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION EXECUTED BY MRS. SALVACION AYUYAO-PENNYA, AS DONOR, OVER A PORTION CONSISTING AN AREA FORTY-ONE **THOUSAND** SEVEN HUNDRED TWENTY-SIX (41,726) SQUARE METERS OF A PARCEL **OF** LAND LOCATED IN BARANGAY SALVACION, THIS CITY, COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. 17471 AND DENOMINATED AS LOT NO. 5857, IN FAVOR OF LGU-ORMOC AS DONEE AND THEREBY, CONVEYING ITS MOST PROFOUND APPRECIATION TO THE DONOR FOR SUCH BENEVOLENT ACT.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated November 21, 2018, requesting therein for the passage of a resolution granting authority to Ormoc City Mayor Richard I. Gomez to accept and sign, for and on behalf of LGU-Ormoc, the Deed of Donation by Mrs. Salvacion Ayuyao-Pennya, as Donor of a portion parcel of land in favor of the LGU-Ormoc as Donee, a copy of said Deed of Donation is hereto attached as Annex "A" and made an integral part thereof;

WHEREAS, the Donor is the registered owner of a parcel of land located at Barangay Salvacion, this City, which were particularly described in the Narrative Technical Description and more particularly described as follows:

## "Transfer Certificate of Title No. 17471

A parcel of land (Lot No. 5857 of the Cadastral Survey of Ormoc), with improvements thereon situated in the Barrio of Salvacion, Municipality of Ormoc, x x x containing an area of Fifty-Seven Thousand Five Hundred and Thirty-Six (57,536) square meters, more or less, registered in the name of Salvacion Ayuyao, of legal age, Filipino, married to Tito Pennya, and a resident of Ormoc City, Phil.";

WHEREAS, as cited in the Deed of Donation, the Donors freely and voluntarily give, transfer and convey by way of donation unto Donee (LGU-Ormoc) a portion of the aforementioned parcel of land together with all the improvements found thereon, with an area of FORTY-ONE THOUSAND SEVEN HUNDRED TWENTY-SIX (41,726) square meters, to be solely and exclusively used for school and educational purposes;

WHEREAS, this august Body believes that said donation is done in good faith, extremely beneficial to the Barangay and to the City in general for the aforementioned donation purpose, and not made for the purpose of defrauding her creditors, having reserved for herself enough and sufficient property to meet her obligations;

WHEREAS, the said donated property shall be considered as forming part of City properties for public use pursuant to the applicable provisions of the Civil Code;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, finds that it is to the best interest of the City and advantageous to the same to authorize the City Mayor to sign the Deed of Donation and accept the said property for educational and education-related purposes located at Barangay Salvacion, this City, and additionally, this august Body conveys its most profound appreciation to the Donor for such benevolence and generosity;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr. Chairman, Committee Laws and Ordinances and SP Member Tomas R. Serafica, Chairman, Committee on Ways & Means, Public Properties & Economic Enterprise, severally seconded by SP Members Mario M. Rodriguez, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Esteban V. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION EXECUTED BY MRS. SALVACION AYUYAO-PENNYA, AS DONOR, OVER A PORTION CONSISTING AN AREA OF FORTY-ONE THOUSAND SEVEN HUNDRED TWENTY-SIX (41,726) SQUARE METERS OF A PARCEL OF LAND LOCATED IN BARANGAY SALVACION, THIS CITY, COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. 17471 AND DENOMINATED AS LOT NO. 5857, IN FAVOR OF LGU-ORMOC AS DONEE AND THEREBY, CONVEYING ITS MOST PROFOUND APPRECIATION TO THE DONOR FOR SUCH BENEVOLENT ACT;

#### DEED OF DONATION

KNOW ALL MEN BY THESE PRESENTS:

This DEED OF DONATION, made and executed by:

SALVACION AYUYAO- PENNYA, Filipino, of legal age, married to Tito Pennya and a resident of 512 Gretna Green Way, Los Angeles, CA, USA, herein represented by GRACE A. MATRIANO, Filipino and with residence and postal address at Ormoc City, Philippines, to be my Attorney in Fact, in my name, as shown by a Special Power of Attorney dated \_\_\_\_\_\_, and hereinafter referred to as the "DONOR";

THE LOCAL GOVERNMENT UNIT OF ORMOC, a municipal corporation created and existing under Philippine laws, with address at Aunubing Street, Brgy. Cogon, Ormoc City, represented by Mayor RICHARD I. GOMEZ, hereinafter referred to as the "DONEE"

## WITNESSETH, that:

The DONOR is the registered and absolute owner of one (1) parcel of land which she acquired by gratuitous title situated in the City of Ormoc, Philippines, more particularly described as follows:

# TRANSFER CERTIFICATE OF TITLE No. 17471

"A parcel of land Lot No.5857of the Cadastral Survey of Grmock, with improvements thereon situated in the Barrio of Salvacion, Municipality of Ormoc. Bounded on the NE. by the Podlos Greek and Lot No. 5855; on the SE., by Lots Nos. 5858,7836,7835 and on the SW. by Lot No.5859; and in the NW. by the Podlos Creek. Beginning at a point marked "1" on plan, being S. 64 deg. 27 E. from B.B.M. The DONOR recognizes and supports the noble task of the DONEE in promoting the education and development of the youth of the City;

The DONGR desires to assist the DONEE and give further impetus to the various education programs being implemented by the City;

NOW THEREFORE, for and in consideration of the foregoing premises and due to the magnaturity of the DONOR, the latter hereby transfers and conveys unto the DONEE, by way of DONATION, a portion of the said parcel of land with an area of FORTY ONE THOUSAND SEVEN HUNDRED TWENTY SIX (41,726) square meters, indicated in the sate Development Plan attached hereto as Annex "A" and made an integral part of this document;

The property donated shall be used solely by the DONEE for a school and educational purposes;

- The DONEE, at its own expense, shall maintain the donated land its immediate surroundings in clean and safe conditions;
- The DONEE shall not sell, assign, transfer, donate, mortgage or otherwise convey of encumber any portion of the property to any person or entity;
- The DONEE must not use the Property for any unlawful purpose/s.

In the event that the conditions of the donation, as contained herein, are not complied with by the DONEE after the latter's failure to comply with the same is brought to its attention, this donation shall be automatically revoked and rendered ineffective and the DONOR shall regain ownership over the property so donated and shall have the right to recover possession of the same.

#### ACCEPTANCE

The DONEE hereby accepts the donation of the aforementioned property as listed in Annex "A", together with the conditions herein imposed, and hereby expresses its gratitude and appreciation for the support, kindness and liberality of the DONOR.
