**A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT
UNIT OF ORMOC OF CABULIHAN UNITED PARENTS
AND FARMERS ASSOCIATION (CUPFA) IN
ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014.**

WHEREAS, this Sanggunian was in receipt of the application of Cabulihan United Parents and Farmers Association (CUPFA), a Civil Society Organization (CSO) seeking for accreditation with the Local Government Unit of Ormoc;

WHEREAS, Cabulihan United Parents and Farmers Association (CUPFA), is a legitimate farmers' association from Barangay Cabulihan, Ormoc City, duly registered under the Department of Labor and Employment (DOLE). Among its objective is to establish an association that will promote mutual aid and protection to its members as well as promote awareness campaign regarding the effect of Global Warming and Climate Change through implementing organic livelihood project such as organic hog raising, layer production and vegetable gardening;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance 009 provides among others that an organization may still be accredited after the prescribed sixty (60) - day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned application finds that the same are in order, and the purposes of the sought are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to establish a strong linkage with the LGU and actively participate in the implementation of the diverse programs and projects of the government to promote inclusive growth;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Cooperatives & Accreditation of Non-Government Organization, severally seconded by the SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Esteban V. Laurente and Jasper C. Yerro; be it
