A RESOLUTION THE SUPPORTING REQUEST OF BARANGAY DONGHOL **ADDRESSED** THE TO DEPARTMENT OF EDUCATION (DEPED) FOR THE CONVERSION OF DONGHOL ELEMENTARY SCHOOL 70 DONGHOL INTEGRATED SCHOOL AND ENDORSING THE BARANGAY RESOLUTION TO DEPED REGIONAL OFFICE FOR APPROPRIATE ACTION.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Vice Mayor dated October 18, 2018, requesting therein for appropriate action the Barangay Resolution No. 8 s 2018 of Brgy. Donghol entitled: "A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION (DEPED), THRU THE HONORABLE CITY MAYOR RICHARD I. GOMEZ FOR THE OPENING OF A BARANGAY INTEGRATED HIGH SCHOOL IN THIS BARANGAY";

WHEREAS, Donghol Elementary School produces a good number of elementary graduates sufficient enough to open one section of Grade VII and in fact in the current school year, there are 71 pupils enrolled in Grade VI of the said school;

WHEREAS, Mahayag Elementary School which is the nearest neighboring barangay to Donghol also have 32 pupils enrolled in Grade VI in the current school year;

WHEREAS, with the diversion road almost finished, additional students are expected to enroll and add to the 103 enrollees from Donghol and Mahayag and these students will come from Patag, Sumangga, Biliboy and Bagong;

WHEREAS, DEPED Division Office explained that fewer elementary graduates from Donghol, Mahayag and nearby barangay would enroll in New Ormoc City National High School (NOCNHS) and they assume that this is because of distance and cost of travel from the barangays to NOCNHS and so the request to open a high school in Donghol will hopefully encourage the graduates to continue their schooling and resolve the problem of drop-outs after elementary education and reduce the incidence of out-of-school youth;

WHEREAS, the request for conversion is also consonant to the thrust of DEPED Division Office to decongest New Ormoc City National High School (NOCNHS) that is currently suffering from heavy congestion and overcrowding of students;

WHEREAS, the request to open a high school in Barangay Donghol is also in line with the thrust of the City Government of Ormoc to open more high schools and make education accessible and affordable to the communities especially the poor;

WHEREAS, the School Head of Donghol Elementary School has submitted the Letter of Intent as required by the Committee on Education and Manpower Development which letter of intent should also endorse the resolution of the Barangay Council of Donghol;

WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc as it will decongest the overcrowded New Ormoc City National High School and encourage the students in uphill communities to continue with their studies so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP member Nolito M. Quilang, Chairman, Committee, on Education and Manpower Development, severally seconded by SP Members Tomas R. Serafica, Mario M. Rodriguez, Esteban V. Laurente and John Eulalio Nepomuceno O. Aparis II; be it

RESOLVED AS IT IS HEREBY RESOLVED, to pass A RESOLUTION SUPPORTING THE REQUEST OF BARANGAY DONGHOL ADDRESSED TO THE DEPARTMENT OF EDUCATION (DEPED) FOR THE CONVERSION OF DONGHOL ELEMENTARY SCHOOL TO DONGHOL INTEGRATED SCHOOL AND ENDORSING THE BARANGAY RESOLUTION TO DEPED REGIONAL OFFICE FOR APPROPRIATE ACTION;
