**RESOLUTION NO. 2018-318**

**A RESOLUTION APPROVING THE APPLICATION FOR  
ACCREDITATION WITH THE LOCAL GOVERNMENT  
UNIT OF ORMOC OF ORMOC-MAASIN TRANSPORT  
COOPERATIVE (OMTC), IN ACCORDANCE WITH THE  
PROVISIONS OF ORDINANCE NO. 009 DATED  
OCTOBER 16, 2014.**

WHEREAS, this Sanggunian received the application of Ormoc-Maasin Transport Cooperative (OMTC), a Civil Society Organization (CSO) seeking for accreditation with the Local Government Unit of Ormoc;

WHEREAS, ORMOC-MAASIN TRANSPORT COOPERATIVE (OMTC), is a transport cooperative composed of regular members from the Province of Leyte and Southern Leyte. OMTC is duly registered under the Cooperative Development Authority;

WHEREAS, among its purpose is to provide public land transport services primarily to members and the commuting public for the safe conveyance of passengers as well as to adopt other plans to help foster the welfare of the members and its families and the community;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned application finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to establish a strong linkage with the LGU and actively participate in the implementation of the diverse programs and projects of the government to promote inclusive growth;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Mario M. Rodriguez, Tomas R. Serafica, Gregorio G. Yrastorza III and John Eulailo Nepomuceno O. Aparis II; be it


