**A RESOLUTION APPROVING AND GRANTING
AUTHORITY TO THE OFFICE OF THE PUBLIC
MARKET ADMINISTRATOR TO PURCHASE ONE
(1) UNIT MULTI-PURPOSE SERVICE VEHICLE
IN THE AMOUNT OF ONE MILLION TWO
HUNDRED THOUSAND PHILIPPINE PESOS.**

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated November 8, 2018 respectfully endorsing the request of Engr. Rodolfo H. Labarda, Jr., Acting Market Administrator, for the passage of a Resolution granting authority to purchase one (1) unit, fifteen (15) seater, Multi-Purpose, Diesel-fed Vehicle, for the amount of ONE MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,200,000.00);

WHEREAS, the requested vehicle shall be used by the Office of the Public Market Administrator, the primary arm of the Local Government Unit of Ormoc City in the maintenance, administration, and operation of the Ormoc City Public Market and other adjacent properties under their administration as provided in the Market Code of the City of Ormoc, as amended, for, among other related functions, the ease of transport of the Public Market Office personnel and equipment to and from the Ormoc City Hall or other destination for official transaction and other events;

WHEREAS, the City Accountant, City Budget Officer, and the City Treasurer issued a Certificate of Availability of Funds dated November 5, 2018 stating therein that the Public Market Office has available funds for the purchase of the aforementioned vehicle in the amount of ONE MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,200,000.00) to be sourced from CY 2017 Unexpended Continuing Appropriation (Capital Outlay for Motor Vehicles), a copy of said certification is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Sangguniang finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;

WHEREFORE, on motion by SP Member Tomas R. Serafica, Member, Committee on Finance and Appropriation, duly seconded by SP Member Gregorio G. Yrastorza III; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION APPROVING AND GRANTING AUTHORITY TO THE OFFICE OF THE PUBLIC MARKET ADMINISTRATOR TO PURCHASE ONE (1) UNIT MULTI-PURPOSE SERVICE VEHICLE IN THE AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,200,000.00);
