**A RESOLUTION AMENDING ANNEXES "A" and "B" OF
SANGGUNIANG PANLUNGSOD NG ORMOC
RESOLUTION NUMBER 2019-001, ENTITLED: "A
RESOLUTION ADOPTING THE INTERNAL RULES OF
PROCEDURE OF THE 15TH SANGGUNIANG
PANLUNGSOD NG ORMOC".**

WHEREAS, this Sanggunian passed Sangguniang Panlungsod (SP) Resolution No. 2019-001 on the noon of June 30, 2019, entitled: "ADOPTING THE INTERNAL RULES OF THE 15TH SANGGUNIANG PANLUNGSOD NG ORMOC" which specifically provided for, among others, for purposes of efficient supervision and administration of the City, the creation of ELEVEN (11) SANGGUNIAN DISTRICTS, the composition of which is reflected in Annex A of said Internal Rules;

WHEREAS, in the creation of the eleven (11) Sanggunian Districts of the 15th Sangguniang Panlungsod, it was observed that there is a need to amend and reorganize certain compositions of the said Districts for purposes of efficient supervision and administration of the City;

WHEREAS, in the establishment and creation of the twenty-two (22) Committees of the 15th Sangguniang Panlungsod, it was observed that there is also a need to amend certain compositions of the standing Committees, particularly the Committee on Communication and Information, the Committee on Trade, Commerce and Industry, and the Committee on Education in order to render effective public service and governance to the constituents of the City of Ormoc;

WHEREAS, in view of the foregoing, the reorganization of the 11 Sanggunian Districts and the 22 Regular Committees of the Sanggunian as afore-described would also necessarily entail the amendment of "Annex A" and "Annex B" of the said Rules as well, so therefore a copy of the new composition of the aforementioned Committees and Barangay Assignments are hereto attached and made integral parts hereof;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Jasper M. Lucero, Vice-Chairman, Committee on Internal Rules of Procedure and Legislative Tracking, severally seconded by SP Members Nolito M. Quilang, Tomas R. Serafica, Vincent L. Rama and Lalaine A. Marcos; be it
