RESOLUTION NO. 2019-025

A RESOLUTION CHOOSING SP MEMBER GREGORIO G. YRASTORZA, III TO BE ONE OF THE MEMBERS OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF ORMOC CITY.

WHEREAS, Section 43 of Republic Act No. 6975 pertains to the establishment of the Philippine National Police (PNP) under the reorganized Department of Interior and Local Government (DILG);

WHEREAS, Section 43, Paragraph (a) of Republic Act No. 6975 mandates for the creation of the People's Law Enforcement Board (PLEB) in every City by their respective Sangguniang Panlungsod which is tasked to receive and decide citizens' complaints against erring officers and members of the Philippine National Police (PNP) within the jurisdiction of Ormoc City;

WHEREAS, Section 43, Paragraph b (1) of Republic Act No. 6975 provides that one of the members of the People's Law Enforcement Board (PLEB) in every City must be any member of the Sangguniang Panlungsod chosen by his respective Sanggunian;

WHEREAS, the decision of choosing the Chairman of the Committee on Justice, Peace and Order, SP Member Gregorio G. Yrastorza, III, as one of the members of the People's Law Enforcement Board (PLEB) Ormoc City was approved at the Committee Level during the August 05, 2019 Joint Committee Meeting of the Committee on Justice, Peace and Order and the Committee on Good Government and Oversight;

WHEREAS, there is a need to pass a Resolution that will choose SP Member Gregorio G. Yrastorza, III as one of its member;

WHEREFORE, foregoing premises considered, on motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government & Oversight, severally seconded by SP Members Lalaine A. Marcos, Esteban V. Laurente, Vincent L. Rama, Peter M. Rodriguez; be it-

RESOLVED, AS IT HEREBY RESOLVED, to pass a RESOLUTION CHOOSING SP MEMBER GREGORIO G. YRASTORZA, III TO BE ONE OF THE MEMBERS OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF ORMOC CITY;
