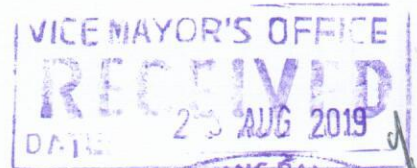

RESOLUTION NO. 2019-036

**A RESOLUTION GRANTING INCENTIVES TO ALL
WINNING ATHLETES AND COACHES IN EASTERN
VISAYAS ATHLETIC ASSOCIATION (EVRAA) MEET
HELD LAST APRIL 7-12, 2019 AT ORMOC CITY
THEREBY SUPERSEDING RESOLUTION NO. 2019-030.**

WHEREAS, this august body passed a resolution dated May 6, 2019 with Resolution No. 2019-103 entitled "A RESOLUTION CONGRATULATING DEPARTMENT OF EDUCATION (DEP ED) ORMOC CITY DIVISION FOR WINNING THE OVER-ALL CHAMPIONSHIP OF THE 2019 EASTERN VISAYAS REGIONAL ATHLETIC ASSOCIATION (EVRAA) MEET ON APRIL 7-12, 2019; AND FURTHER COMMENDING THE CITY GOVERNMENT OF ORMOC FOR THE PEACEFUL AND SUCCESSFUL HOSTING OF THE SAID EVRAA MEET" which is related to the above stated premise;

WHEREAS, this august body finds to grant only the winning athletes of 2019 EASTERN VISAYAS REGIONAL ATHLETIC ASSOCIATION (EVRAA) MEET ON APRIL 7-12, 2019 at ORMOC CITY and not the winning athletes and coaches of 2019 PALARONG PAMBANSA since the latter's granting of incentives are covered under City Ordinance Number 056 series of 2018;

WHEREAS, this august body received an endorsement from the Office of the City Mayor dated July 1, 2019 endorsing the said resolution passed by Local School Board (LSB) with Board Resolution No. 2019-07 entitled "A RESOLUTION ENDORSING TO THE SANGGUNIANG PANLUNGSOD THE GRANT OF CASH INCENTIVES FOR THE MEDALIST OF THE EVRAA MEET 2019 AND PALARONG PAMBANSA AND REQUEST ADDITIONAL BUDGET FROM CITY MAYOR'S OFFICE FOR PALARONG PAMBANSA MEDALISTS" for the consideration of the august body and for the enactment/passage of the required and necessary Ordinance/Resolution which certified as URGENT;

WHEREAS, the august body did not include the granting of the proposed cash incentives in relation to the above stated premise because of the prohibition under Omnibus Election Code, Article XXII(v) which prohibits against release, disbursement or expenditure of public funds forty-five days before a regular election, the national and local election having held last May 13, 2019;

WHEREAS, this August body deems it appropriate that incentives are to be given to the Athletes and Coaches medal winners in the form of the following to wit:

For Team Sports:

Gold	-Php 20,000.00
Silver	-Php 18,000.00
Bronze	-Php 15,000.00

For Individual Sports:

Gold	- Php 5,000.00
Silver	- Php 3,000.00
Bronze	- Php 2,000.00

For the Coaches, they shall be given Three Thousand Pesos (Php 3,000.00) each;

WHEREAS, This August body has passed a resolution dated August 13, 2019, Resolution No. 2019-030, entitled "A RESOLUTION GRANTING INCENTIVES TO THE WINNING ATHLETES AND COACHES IN 2019 EASTERN VISAYAS ATHLETIC ASSOCIATION (EVRAA) HELD LAST APRIL 7-12, 2019 AT ORMOC CITY, however, the City Accounting Office could not allow in audit the release of funds because there is a discrepancy of the figures stated in the said resolution which caused as hindrance for the release of the funds;

WHEREAS, to remove the hindrance for the City Accounting Office to allow in audit it is proper to supersede the previous resolution no. 2019-030 by passing a new resolution without stating therein the figures that caused the hindrance for the accounting office to allow in audit for the release of funds;

WHEREAS, this Sanggunian finds that the Resolution is not contrary to law, public policy, public morals and that this endeavor will greatly benefit the inhabitants of Ormoc City thereby deserving of this august body's full support and affirmative action.

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP MEMBER JASPER C. YERRO, Chairman of the Committee on Youth and Sports, severally seconded by SP Members Nolito M. Quilang, Tomas R. Serafica, Roiland H. Villasencio, Jasper M. Lucero, Gregorio G. Yrastorza III and Esteban V. Laurente; Be it;


