## RESOLUTION NO. 2019-037

A RESOLUTION CONFIRMING THE COMPOSITION OF THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB), AS CONTAINED IN EXECUTIVE ORDER NO. 42-A SERIES OF 2019, SUBJECT TO THE PROVISIONS OF CSC MEMORANDUM CIRCULAR NO. 24, S. 2017 BASED ON CSC RESOLUTION NO. 1701009.

WHEREAS, the Civil Service Commission (CSC), has issued Memorandum Circular No. 24, S. 2017 based on CSC Resolution No. 1701009 explicitly stating the composition of the Human Resource Merit Promotion and Selection Board who shall be primarily responsible for the judicious and objective selection of candidates for appointment and shall recommend to the appointing authority the top five (5) ranking candidates deemed most qualified to the vacant positions;

WHEREAS, the Sangguniang Panlungsod received communication from the Office of the City Mayor certified as very urgent requesting for the issuance of a resolution confirming the composition of the Human Resource Merit Promotion and Selection Board (HRMPSB), as contained in Executive Order No. 42-A Series of 2019;

WHEREAS, Section 80, par. (b) & (c) of the Local Government Code of 1991 provides for the establishment of a Personnel Selection Board who will assist the Local Chief Executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of such policies as would contribute to employee welfare.

WHEREAS, this Sanggunian finds that the confirmation of the composition of the Human Resource Merit Promotion and Selection Board (HRMPSB) as contained in Executive Order No. 42-A S. 2019 is not contrary to law, public morals, public policy, rules and regulations of the Civil Service Commission and thereby deserving of this august Body's affirmative action;
