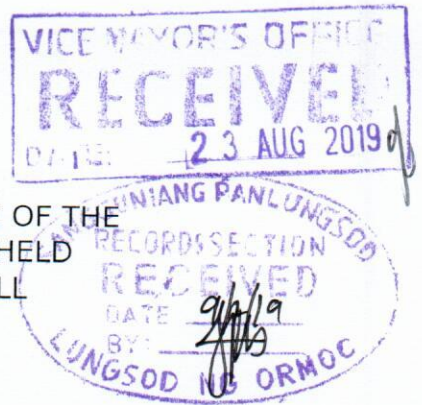



ADOPTED, August 20, 2019.


