WHEREAS, this august Body is in receipt of three (3) separate applications for accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, the TAHQFA, duly registered with the Department of Labor and Employment on August 23, 2010, is an organization of farmers from Barangay Milagro, Ormoc City which seeks to improve the standard of living of their members and enhance their general welfare through the planting of seedlings;

WHEREAS, the Hibunaon Working Fathers Association, duly registered with the Department of Labor and Employment on August 16, 2018, is an organization of working fathers from Barangay Hibunaon which seeks to develop a sustainable livelihood among its members through their partnership with the Local Government Unit of Ormoc City;

WHEREAS, the Ormoc Federation of Sustainable Program Association, Inc. is a federation duly registered with the Securities and Exchange Commission on April 24, 2018, a federation committed to promote the members' economic independence and social responsibility through active partnership among themselves and with other association movements;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which govern the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned three (3) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;
