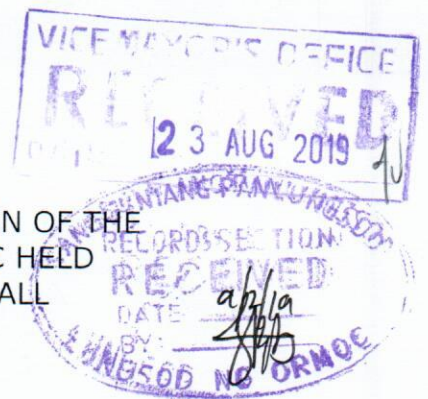

UNIT OF ORMOC, IN ACCORDANCE WITH THE
PROVISIONS OF ORDINANCE NO. 009 DATED
OCTOBER 16, 2014 OF THE FOLLOWING CIVIL

WHEREAS, this august Body is in receipt of Eleven (11) separate applications for renewal of accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, the CUPFA, duly registered with the Department of Labor and Employment on November 24, 2016, is an organization of farmers from Barangay Cabulihan, Ormoc City working together to develop a sustainable livelihood through the conduct of activities with the end goal of uplifting the economic condition of its members;

WHEREAS, the GALFA, duly registered with the Department of Labor and Employment on August 29, 2017, is an organization of farmers from Barangay Gaas, Ormoc City working together to provide its members with knowledge and skills and equip themselves of effective and innovative ways of livelihood and farming;

WHEREAS, the GREVAFA, duly registered with the Department of Labor and Employment on October 14, 2015, is an organization of farmers from Barangay Green Valley, Ormoc City which seek to promote social and economic well-being of its members by attending seminars and training conducted by the government and other non-government organizations;

WHEREAS, the QUEUFA, duly registered with the Department of Labor and Employment on August 11, 2014, is an organization of farmers from Barangay Quezon Jr., Ormoc City which seeks to uplift the small farmers and their families in the rural agricultural sector through technical and education training to enhance and improve their members' living in the community;

WHEREAS, the BFA, duly registered with the Department of Labor and Employment on January 16, 2012, is an organization of farmers from Barangay Bugho, Ormoc City seeking to establish legal personality in working with the government and other non-government organizations in the promotion and development of the association and in carrying - out government policies;

WHEREAS, the ALA, duly registered with the Securities and Exchange Commission on June 13, 2016, is an organization which seeks to embark on various livelihood programs with the Local Government Unit of Ormoc City for its members;

WHEREAS, the MARFA, duly registered with the Department of Labor and Employment on June 9, 2015, is an organization of farmers from Barangay Margen, Ormoc City which aims to establish black rice production in order to sustain the organic production of their association;

WHEREAS, the SANVICUFA, duly registered with the Department of Labor and Employment on October 29, 2014, is an organization of farmers from Barangay San Vicente, Ormoc City which seeks to improve the standard of living and quality of life of their members;

WHEREAS, the GUIFA, duly registered with the Department of Labor and Employment on May 24, 2016, is an organization of farmers from Barangay Guintigui-an, Ormoc City working together to promote enterprise development activities that will improve the economic and social well-being of their members;

WHEREAS, the LANGKA, duly registered with the Department of Labor and Employment on March 23, 2015, is an organization of women from Barangay San Jose, Ormoc City aiming to promote mutual aid and protection among its members;

WHEREAS, the PMPC, duly registered with the Cooperative Development Authority on November 26, 2014, is a cooperative which seeks to improve the quality of life of its members by engaging into buy and sell of abaca fiber, copra trading and any agricultural products;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which govern the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned eleven (11) separate applications for renewal of accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Roiland H. Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Peter M. Rodriguez, Gregorio G. Yrastorza III, Lalaine A. Marcos, Esteban V. Laurente, Nolito M. Quilang, Eusebio Gerardo S. Penserga and Jasper M. Lucero; be it
