WHEREAS, the DOLFA, duly registered with the Department of Labor and Employment on May 24, 2016, is an organization of farmers from Barangay Dolores, Ormoc City, practicing sustainable farming technology as part of the campaign on "Protection of our Environment and Saving Mother Earth."

WHEREAS, the LFO, duly registered with the Department of Labor and Employment on July 31, 2009, is an organization of fisherfolks working together to protect the natural resources of Barangay Lao with its coordination with the Local Government Unit;

WHEREAS, the KAMAO, Inc., duly registered with the Securities and Exchange Commission on January 27, 1991, is an organization of self-reliant farmers willing to forge alliance with the other organization to ensure food security;

WHEREAS, the MUSFA, duly registered with the Department of Labor and Employment on January 25, 2002, is an organization of farmers from Barangay Mahayag, this City, working together in promoting enterprise development activities that will improve the economic and social well-being of their members;

WHEREAS, the LIVEFA, duly organized on January 20, 2015, is an organization of farmers from Barangay Libertad, this City, working together to develop a sustainable livelihood through the conduct of activities with the end goal of uplifting the economic condition of the members;

WHEREAS, the BDaSFA, duly registered with the Department of Labor and Employment on February 10, 2016, is an organization of farmers from Barangay Dayhagan, this City, working together to promote mutual aid and protection to its members;

WHEREAS, the RDII, duly registered with the Department of Labor and Employment on November 14, 2014, is an organization striving for the genuine empowerment and disaster preparedness of marginalized rural sectors, peoples and communities;

WHEREAS, the BHW, duly registered with the Department of Labor and Employment on May 20, 2015, is an organization of self-reliant health workers serving this city by addressing concerns in the health service sector;

WHEREAS, the MARSFA, duly registered with the Department of Labor and Employment on January 25, 2016, is an organization of farmers from Barangay Margen and San Juan, this City, working together to develop a sustainable livelihood through the conduct of activities with the aim of uplifting the economic condition of the members;

WHEREAS, the SALUFA, duly registered with the Department of Labor and Employment on June 9, 2015, is an organization of farmers from Barangay Salvacion, this City, working together to promote the moral, social, and economic well-being of all the members;

WHEREAS, the JUFA, duly registered with the Department of Labor and Employment on December 12, 2016, is an organization of farmers from Barangay Juaton, this City, which seeks to develop the organization and the community into sustainable and productive unit;

WHEREAS, the SALASAFA, duly registered with the Department of Labor and Employment on December 12, 2016, is an organization of farmers from Barangay Sabang Bao, Barangay Labrador, and Barangay San Jose, this City, working together in mobilizing their members and the community towards development;

WHEREAS, the VASFA, duly registered with the Department of Labor and Employment on February 24, 2009, is an organization of farmers from Barangay Valencia, this City, which seeks to actively participate and support the government in its programs and economic welfare.

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;
