AN OMNIBUS RESOLUTION APPROVING THE THREE (3)
SEPARATE APPLICATIONS FOR ACCREDITATION
WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 202 DATED OCTOBER 16, 2014 OF
THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS,
TO WIT:

- 1) ASOSASYON SA MGA MAG-UUMA SA BAGONG (AMBAG);
- 2) AGRIBUSINESS FEDERATION OF MULTIPURPOSE COOPERATIVES FOR RURAL EMPOWERMENT (AFFIRE); and
- 3) MAHAYAG WOMEN ASSOCIATION OF ORMOC (MAWA)

WHEREAS, this august Body is in receipt of three (3) separate applications for accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, the AMBAG, duly registered with the Securities and Exchange Commission on February 14, 2018, is an organization of farmers from Barangay Bagong, this City, which actively participates in the tree planting activities in Barangay Lake Danao with the ex-convict citizens, honing them to become economically viable again in the society;

WHEREAS, the AFFIRE, duly registered with the Cooperative Development Authority on April 22, 2015, which seeks to carry on any cooperative enterprise authorized under Republic Act No. 9520, otherwise known as the "Philippine Cooperative Code of 2008," that compliments, augments and supplements the business or economic activities of its affiliates;

WHEREAS, MAWA, duly registered with the Department of Labor and Employment on September 28, 2017, is an organization of women from Barangay Mahayag, this City, working together to improve women's standard of living and enhance their general welfare;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned three (3) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
