AN OMNIBUS RESOLUTION APPROVING THE NINE (9) SEPARATE APPLICATIONS FOR RENEWAL OF ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

WHEREAS, this august Body is in receipt of nine (9) separate applications for renewal of accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, MOFA, duly registered with the Department of Labor and Employment on June 14, 2016, is an organization of organic farmers from Barangay Matica-a, this City, working together to promote mutual aid and protection among its members;

WHEREAS, BISFA, duly registered with the Department of Labor and Employment on January 25, 2016, is an organization of farmers from Barangay Bantigue, Ipil and Sumangga of this City, seeking to develop alternative projects aimed at uplifting the economic conditions of their members;

WHEREAS, DUSFA, duly registered with the Department of Labor and Employment on August 18, 2017, is an organization of farmers from Barangay Dayhagan, this City, dedicating their hard work in tilling one (1) hectare of land in planting macho sweet corn;

WHEREAS, KAABAG, duly registered with the Securities and Exchange Commission on March 24, 2010, is an organization which envisions to turn Ormoc as a City where values-driven and empowered citizens work together for a well governed community;

WHEREAS, ECLIPSE, duly registered with the Securities and Exchange Commission on September 2, 1998, is an organization which seeks to facilitate the exodus of working children from child labor and exploitation to the fullest enjoyment of their rights for their protection, development and active participation in social transformation toward a free, prosperous, good and happy life for children;

WHEREAS, the BACOSFA, duly registered with Department of Labor and Employment on October 15, 2015, is an organization of farmers with the primary objective of establishing an organization that will promote mutual aid and protection to its members through the conduct of rice, sugarcane, corn and vegetable cultivation;

WHEREAS, the SUFA, duly registered with the Department of Labor and Employment on May 24, 2016, is a barangay – based organization of farmers from Barangay Surnangga, this City, which seeks to uplift the small farmers and their families in the rural agricultural sector through technical and education training such as but not limited to Upland Rice Orientation, Farmer Leaders Credit Forum and Financial Management Training Orientation to enhance and improve their members' living in the community;

WHEREAS, LEYBEA – MPC, duly registered with the Cooperative Development Authority on October 27, 2009, with the primary objective to undertake supply on electrical housewiring materials, meter boxes and contract on installation of electrical works and sketch plan. Among its purposes is to coordinate and facilitate the activities of the cooperative and to ensure the viability of cooperatives through the utilization of new technologies;

WHEREAS, the FEVMA, duly registered with the Securities and Exchange Commission on May 14, 2013, is a federation of motorcyclists that seeks to unite all motorcycle club or alliance or federation in Eastern Visayas for a stronger coordinated force in the realization of their common interests and welfare;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned nine (9) separate applications for renewal of accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;
