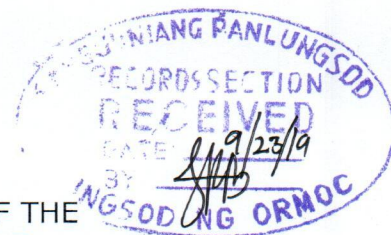

RESOLUTION NO. 2019-055

**A RESOLUTION CONFIRMING THE APPOINTMENT OF
DELIA D. CORBO, AS CITY GOVERNMENT
DEPARTMENT HEAD I (CITY SOCIAL WELFARE
DEVELOPMENT OFFICER).**

WHEREAS, Section 454 (d) of RA 7160, otherwise known as the Local Government Code of 1991, provides that heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to the civil service law, rules and regulations and that the Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the dates of its submission;

WHEREAS, the appointment of Delia D. Corbo as City Government Department Head I (City Social Welfare Development Officer) was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for confirmation on August 8, 2019 and was referred to the Committee on Good Government and Oversight on August 20, 2019;

WHEREAS, after careful examination, scrutiny and review of the qualifications, records and experiences of the appointee pursuant to the requirements under Article 13, Section 483 of RA 7160, the Sangguniang Panlungsod finds the appointment meritorious considering that the appointee possesses all the minimum qualifications set by law for the position and that she has none of the disqualifications under the local Government Code or other existing laws;

WHEREAS, pursuant to Civil Service Rules and Regulations, the Sangguniang Panlungsod concurs in the appointment by the City Mayor of Ormoc, Richard I. Gomez, of Delia D. Corbo as City Government Department Head I (City Social Welfare Development Officer);

WHEREFORE, on motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government and Oversight, severally seconded by SP Members Nolito M. Quilang, Gregorio G. Yrastorza III, Vincent L. Rama, Esteban V. Laurente and Jasper C. Yerro;

RESOLVED, by the Sangguniang Panlungsod in session assembled to confirm, as it is hereby confirmed, THE APPOINTMENT OF DELIA D. CORBO, AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY SOCIAL WELFARE DEVELOPMENT OFFICER);


