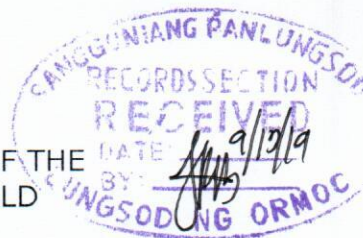

**RESOLUTION NO. 2019-061**

**A RESOLUTION APPROVING THE TWO (2) SEPARATE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:**

- 1. LEYTE TRANSPORT COOPERATIVE (LETRANSCO);**
- AND**
- 2. SIGMA LAMBDA PHI FRATERNITY AND SORORITY.**

WHEREAS, this august Body is in receipt of two (2) separate applications for accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, LETRANSCO, duly registered with the Cooperative and Development Authority on May 11, 2018, is a cooperative providing public land transport services primarily to its members and the commuting public for the safe conveyance of passengers, and to this end, it promotes and advances the economic and social status of its members;



WHEREAS, the Sigma Lambda Phi Fraternity and Sorority, duly registered with the Securities and Exchange Commission on October 3, 2012, a fraternal organization that aims for a stronger and more active brotherhood or sisterhood among their members with the Local Government Unit of Ormoc. Its primary objective among others is to promote scholarship, leadership and humanitarian service that shall foster, encourage and inspire relationships for the general welfare of the people;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned two (2) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Member, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Vincent L. Rama, Esteban V. Laurente, Jasper C. Yerro and Peter M. Rodriguez; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION APPROVING THE TWO (2) SEPARATE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:


1. LEYTE TRANSPORT COOPERATIVE (LETRANSCO); AND
2. SIGMA LAMBDA PHI FRATERNITY AND SORORITY.
