AN OMNIBUS RESOLUTION APPROVING THE SIX (6) SEPARATE APPLICATIONS FOR RENEWAL ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

WHEREAS, this august Body is in receipt of six (6) separate applications for renewal of accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, Ormoc Kananga Mill District Development Council Foundation, Inc., duly registered with the Securities and Exchange Commission on November 13, 2000, is an organization which seeks to promote the efforts of the sugar planters and millers in the production and marketing of the sugar industry and in furtherance thereof, the organization commits to institutionalize and promote sugar research, studies and development;

WHEREAS, GIFA, duly registered with the Department of Labor and Employment on March 29, 2017, is a barangay – based organization of farmers from Barangay Guintigui-an, this City, which seeks to develop sustainable livelihood among their members through the conduct of activities, such as but not limited to the Convergence on Livelihood Assistance for Agrarian Reform Beneficiaries Project;

WHEREAS, SOFAOC, duly registered with the Department of Labor and Employment on August 10, 2016, is an organization which seeks to provide its members with the knowledge and skills in the innovative way of Integrated Diversified Organic Farming System;

WHEREAS, OPROCOMA Agro – Industrial Multipurpose Cooperative, duly registered with the Cooperative Development Authority on July 17, 2017, which undertakes to market sugar and molasses products of the planter – members and to sell agricultural farm implements, fertilizers, chemicals, agricultural machinery and equipments needed by the planter – members to cultivate their farms;

WHEREAS, ORPFLOMCO, duly registered with the Cooperative Development Authority on December 29, 2009, is a cooperative which participates in activities for environmental protection and engages in landscaping, flower arrangement, agro-trade fair, beautification of home, parks and other government – owned areas;

WHEREAS, OMIMODATCO, duly registered with the Cooperative Development Authority on February 20, 2018, is a cooperative which seeks to help improve the quality of life of its members thereby contributing to its inclusive growth, enterprise development and employment. In furtherance thereto, it shall actively support the government, other cooperatives and people – priented organizations, in promoting the cooperative as a practical means towards sustainable socio-economic development.

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned six (6) separate applications for renewal of accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
