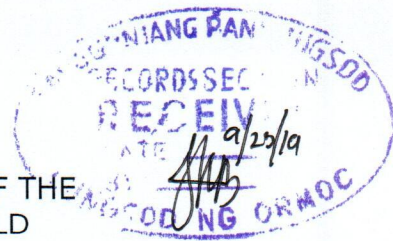

WHEREAS, this august Body is in receipt of an application for renewal of accreditation of the ORCHAM requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, ORCHAM, duly registered with the Securities and Exchange Commission on November 13, 2018, is an organization which recognizes the importance of strong partnership with the Local Government of Ormoc City for the interest of the businesses in the locality, in connection to this, it has actively organized the giving of business awards to entrepreneurs and business establishments who have shown exemplary contributions to the local economy of Ormoc City and to the society, in general;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;




