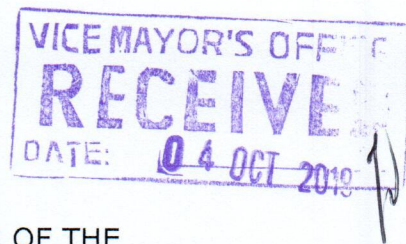

2. BARANGAY TONGONAN


