A RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 FOR CY 2019 OF THE CITY OF ORMOC IN THE TOTAL AMOUNT OF SEVENTY MILLION EIGHT HUNDRED EIGHTY-SIX THOUSAND NINETY PHILIPPINE PESOS (PHP70,886,090.00), THEREBY ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 6, SERIES OF 2019.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Endorsement dated October 3, 2019 from the City Mayor Richard I. Gomez forwarding the City Development Council (CDC) Resolution No. 6, s. of 2019, entitled "A RESOLUTION APPROVING THE CY 2019 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE ADOPTION OF THE SAME";

WHEREAS, the CY 2019 Supplemental AIP No. 3 involves a total investment of SEVENTY MILLION EIGHT HUNDRED EIGHTY-SIX THOUSAND NINETY PHILPPINE PESOS (PHP70,886,090.00) for the identified projects, programs and activities to be implemented during the year which are expected to spur economic growth and development in the City of Ormoc.

WHEREAS, the lists of the proposed programs and projects comprising the CY 2019 Supplemental AIP No. 3 are hereto attached and made an integral part of this resolution;

WHEREAS, the City Development Council (CDC) believes that all identified projects in the CY 2019 Supplemental AIP No. 3 are in conformity with the present needs of the city thus, vital to its continued progress and development, and it encompass the priority programs and services responsive to the needs of the Ormocanon people;
