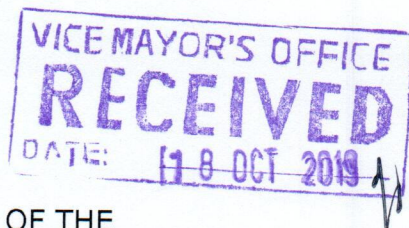

**RESOLUTION NO. 2019-090**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO IDENTIFY AND IMPLEMENT PROGRAM ITEMS WHICH ARE APPROPRIATED IN GENERIC TERMS UNDER THE 2020 ANNUAL INVESTMENT PROGRAM (AIP) PROVIDED, THAT A LIST OF IDENTIFIED AND PROGRAMMED INFRASTRUCTURE PROJECTS APPROPRIATED IN GENERIC TERMS FOR A PARTICULAR MONTH BE SUBMITTED TO THE SANGGUNIANG PANLUNGSOD ON OR BEFORE THE 15<sup>TH</sup> DAY OF THE SUCCEEDING MONTH.**

WHEREAS, the 15<sup>th</sup> Sangguniang Panlungsod ng Ormoc received an Indorsement dated October 3, 2019 from the City Mayor Richard I. Gomez relative to the City Development Council (CDC) Resolution No. 5, Series of 2019, entitled: "A RESOLUTION AUTHORIZING THE HON. CITY MAYOR RICHARD I. GOMEZ TO IDENTIFY AND IMPLEMENT PROGRAMS ITEMS WHICH ARE APPROPRIATED IN GENERIC TERMS (AIP 2020) PROVIDED, THAT A LIST OF IDENTIFIED AND PROGRAMMED INFRASTRUCTURE PROJECTS APPROPRIATED IN GENERIC TERMS FOR A PARTICULAR MONTH BE SUBMITTED TO THE HON. SANGGUNIANG PANLUNGSOD NG ORMOC ON OR BEFORE THE 15<sup>TH</sup> DAY OF THE SUCCEEDING MONTH AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME;"

WHEREAS, the CDC has passed and approved the aforesaid resolution to promote effective, efficient and economical governance which will redound to the general welfare of the Ormoc City constituents;



WHEREAS, granting the authority for the City Mayor to identify and implement program items which are appropriated in generic terms (AIP 2020) subject to the condition prescribed thereat, is deemed more practical and convenient process to the city government in order to fast track the implementation of the priority infrastructure projects of the city which are deemed responsive to the present needs and envisioned to propel local economic growth and development;

WHEREAS, the august Body considers the request of the City Development Council as contained in the CDC Res. No. 5 to be substantial and reasonable hence, the matter is most deserving of prompt and favorable consideration;

WHEREFORE, on motion presented by SP Member Esteban V. Laurente, Chairman, Committee on Infrastructure Development, severally seconded by SP Members Tomas R. Serafica, Jasper C. Yerro and Peter M. Rodriguez; be it


