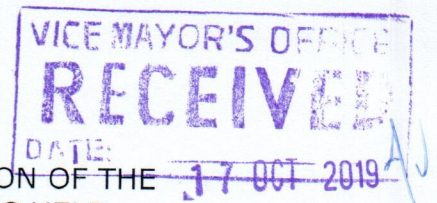

**RESOLUTION NO. 2019-099**

**A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE "HOSPITAL" IN ORDER TO ENSURE THAT ALL PERSONS JOINING AND PARTICIPATING IN THE DIFFERENT ACTIVITIES OF THE CHARTER DAY 2019 CELEBRATION BE GIVEN QUALITY HEALTH CARE AND URGENT MEDICAL ATTENDANCE WHEN NEEDED.**

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated October 14, 2019 forwarded to the 15<sup>th</sup> Sanggunian for consideration the Memorandum of Agreement (MOA) to be entered into by the Local Government Unit of Ormoc (LGU-Ormoc) with the "Hospital" to ensure that all persons joining and participating in the different activities of the Charter Day 2019 Celebration be given quality health care and urgent medical attendance when needed, further requesting that the matter be treated as EXTREMELY URGENT, a copy of the final MOA is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Local Government Unit of Ormoc (LGU-Ormoc) is a political subdivision mandated to assist in improving the health, safety and welfare of the people of Ormoc;

WHEREAS, Article II, Section I of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Article XIII, Section II further states that the State shall also adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people at an affordable cost;



WHEREAS, the implementation of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, resulted in the devolution of health services to local government units (LGUs) which included among others the provision, management and maintenance of health services at different levels of LGUs;

WHEREAS, in view of the aforementioned mandates, LGU-Ormoc seeks to establish partnerships with duly-licensed hospitals in Ormoc City in order to ensure the effective delivery of medical health and welfare services especially in times of emergencies and disasters;

WHEREAS, the City of Ormoc will be celebrating its 72<sup>nd</sup> Charter Day on October 20, 2019, during which time, guests and Ormocanons are expected to join and participate in the many activities for the whole month of October, organized in celebration of the occasion;

WHEREAS, there are certain Hospitals duly licensed which have the medical facilities and personnel equipped to provide hospital and medical care in case of any emergencies;

WHEREAS, this Sanggunian finds this MOA in order, pursuant to the provisions of Section 455, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the City Mayor to represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod concerned pursuant to law or ordinance;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, finds that the same is entered into for the best interests of the City, her constituents and guests;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee Laws and Ordinances, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Vincent L. Rama and Esteban V. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE "HOSPITAL" IN ORDER TO ENSURE THAT ALL PERSONS JOINING AND PARTICIPATING IN THE DIFFERENT ACTIVITIES OF THE CHARTER DAY 2019 CELEBRATION BE GIVEN QUALITY HEALTH CARE AND URGENT MEDICAL ATTENDANCE WHEN NEEDED;



- d. Coordinate with proper parties regarding patient care and Hospital requirements.

## II. HOSPITAL

- a. Appoint a Focal person/Liaison Officer who shall be responsible for the implementation of this MOA on the part of the Hospital;
- b. Provide appropriate medical care and humane treatment to all persons who might be in need of urgent medical care on the occasion of the Charter Day 2019;
- c. Patients in emergency by reason of the Charter Day 2019 shall be extended immediate medical care and treatment without any deposit, pledge, mortgage or any form of advance payment or treatment;
- d. Provide patients with clear, truthful and substantial explanation, in a manner and language understandable to them, of all proposed procedures, whether diagnostic, preventive, curative, rehabilitative or therapeutic.

**ARTICLE II.** All costs for medical attendance will be for the account of the party(ies) concerned and/or agencies offering assistance.


