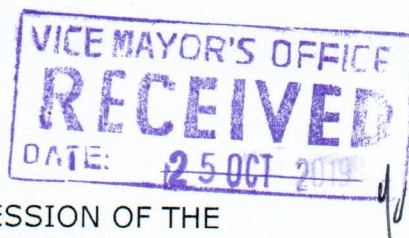

**RESOLUTION NO. 2019-105**

**AN OMNIBUS RESOLUTION APPROVING THE FIVE (5) SEPARATE APPLICATIONS FOR RENEWAL OF ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:**

- 1. FRAN WORKERS AND FARMERS ASSOCIATION;**
- 2. ORMOC CITY FISHPOND OPERATORS' ASSOCIATION (OCFOA);**
- 3. LACASNA FARMER IRRIGATORS MULTIPURPOSE COOPERATIVE (LACASNA FIMPCO);**
- 4. ORMOC SOUTH DISTRICT FARMER IRRIGATORS SERVICE COOPERATIVE (OSDI FISCO); AND**
- 5. PERPETUAL HELP MULTIPURPOSE COOPERATIVE.**

WHEREAS, this august Body is in receipt of five (5) separate applications for renewal of accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;



WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty – day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, Fran Workers and Farmers Association, duly registered with the Department of Labor and Employment on 25 January 2016, is an organization of farmers which aims to provide its members with knowledge and skills in effective and innovative way in organic farming, to this end, they participate in trainings, orientations and workshops conducted for their welfare;

WHEREAS, OCFOA, duly registered with the Department of Labor and Employment on 16 October 2013, is an organization of fishpond operators which seeks to promote mutual aid and protection to its members, to this end, they are making samples on how to make organic feeds for their tilapias and tilanggit;

WHEREAS, LACASNA FIMPCO, duly registered with the Cooperative Development Authority (CDA for brevity) on 9 November 2009, is a cooperative which undertakes palay trading, type I contract of irrigation system, management and facilitation of agricultural inputs, crop protection, post harvest facilities and marketing of produce and lending operation;

WHEREAS, OSDI FISCO, duly registered with the CDA on 18 March 2010, is a cooperative which provides irrigation water service, farm machinery and farm inputs trading through the aid and support of the local government as well as the National Irrigation Administration;

WHEREAS, Perpetual Help Multipurpose Cooperative, duly registered with the CDA on 27 November 2009, is a multipurpose cooperative which engages in activities such as but not limited to extending credit to members of the cooperative for productive and provident purposes at reasonable rate of interests, establish other loan facility responsive to the needs of the members such as housing, education, health and other services and to operate an institution of learning that will offer a range of core competencies prescribed for pre-elementary, elementary, secondary and tertiary education;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned five (5) separate applications for renewal of accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;



NOW THEREFORE, on motion of SP Member Roiland H. Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Lalaine A. Marcos, Esteban V. Laurente ; be it
