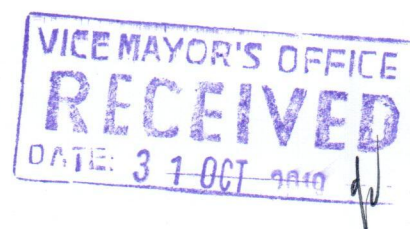

RESOLUTION NO. 2019-108

**A RESOLUTION APPROVING CDC RESOLUTION NO. 9,
SERIES OF 2019, ENTITLED, "A RESOLUTION
APPROVING THE CREATION OF THE PMC (PROJECT
MONITORING COMMITTEE)".**

WHEREAS, DILG Memorandum Circular No. 2004-78 was issued to facilitate project implementation and devolve facilitation, problem-solving, monitoring and evaluation of foreign, national and locally funded projects;

WHEREAS, in view of the above thereof all provinces, cities and municipalities are directed to organize local PMCs in their respective areas of jurisdiction if they are not yet established or if already existing, reactivate or reconstitute said local PMCs to include the following as mandatory members [Section 4.1, RPMS (Regional Project Monitoring System) Manual of Operations]:

1. The DILG official assigned in the locality;
2. Two (2) NGO or PO representatives
3. Four (4) members to be appointed by the Local Chief Executive from among the nominees of the Local Development Council

WHEREAS, this august Body finds the creation of the Project Monitoring Committee (PMC) to be consistent of the said provision;

WHEREAS, scope and coverage of PMC monitoring responsibilities are the following:

1. Foreign and national-funded projects including development projects funded from the Internal Revenue Allotment (IRA) share of LGU or supported funds release directly to the city.
2. Projects funded from the locally-generated resources.

WHEREFORE, on motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government & Oversight, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Gregorio G. Yrastorza III, Esteban V. Laurente and Vincent L. Rama; be it

RESOLVED, AS IT HEREBY RESOLVED, to pass A RESOLUTION APPROVING CDC RESOLUTION NO. 9, SERIES OF 2019, ENTITLED, "A RESOLUTION APPROVING THE CREATION OF THE PMC (PROJECT MONITORING COMMITTEE)";

ADOPTED, October 29, 2019.
