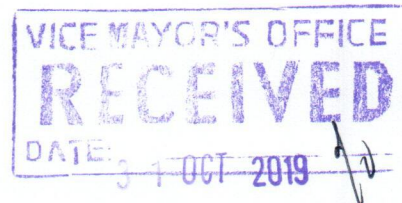

RESOLUTION NO. 2019-110

**AN OMNIBUS RESOLUTION APPROVING THE THREE (3)
SEPARATE APPLICATIONS FOR ACCREDITATION
WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF
THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS,
TO WIT:**

- 1. SAN VICENTE FARMERS AND WORKERS ASSOCIATION;**
- 2. KIWANIS CLUB OF GEO - ORMOC; AND**
- 3. DUTERTE RIDERS TEAM CEBU INC - ORMOC CHAPTER (DRT - ORMOC).**

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty - day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of three (3) separate applications for accreditation of the aforementioned civil society organizations;

WHEREAS, San Vicente Farmers and Workers Association, duly registered with the Department of Labor and Employment on 2 August 2018, is an organization of farmers which aims to establish an association that will promote mutual aid and protection amongst its members, to this end, it has conducted its community savings and credit project to alleviate the current station of life of its members;

WHEREAS, KIWANIS Club of Geo - Ormoc, duly registered with the Securities and Exchange Commission on 28 July 2017, is an organization whose primary purpose is to improve the quality of life for children and families worldwide by adhering to the objects of Kiwanis International, which among others include, giving primacy to the human and spiritual value of life, encouraging the daily living of the Golden Rule in all human relationships and the promotion of the adoption and application of higher social, business and professional standards;

WHEREAS, DRT - ORMOC, duly registered with the Securities and Exchange Commission on 18 August 2016, which seeks to extend and continue its mission in helping the community and supporting the advocacies of President Rodrigo R. Duterte with regard to Federalism, Anti-Drug and Anti - Corruption Campaigns for a better and safer future, in furtherance thereof, it has participated in many volunteer activities;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned three (3) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Roiland H. Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Tomas R. Serafica, Nolito M. Quilang, Vincent L. Rama and Esteban V. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION APPROVING THE THREE (3) SEPARATE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:
