RESOLUTION NO. 2019-111

**A RESOLUTION APPROVING AND FAVORABLY
ENDORISING TO THE DEPARTMENT OF PUBLIC
WORKS AND HIGHWAYS (DPWH) THE FOLLOWING
PROPERTIES AS LOCATIONS FOR THE
CONSTRUCTION OF EVACUATION CENTERS, TO WIT:**

- 1. BRGY. GAAS, NATIONAL HOUSING AUTHORITY (NHA) HOUSING DEVELOPMENT;**
- 2. BRGY. DOLORES, NATIONAL HOUSING AUTHORITY (NHA) HOUSING DEVELOPMENT; AND**
- 3. BRGY. LAKE DANAOS, NATIONAL HOUSING AUTHORITY (NHA) HOUSING DEVELOPMENT.**

WHEREAS, enshrined in Section 16 of the Local Government Code of 1991 are the responsibilities of the local government unit to espouse the general welfare, of its inhabitants, within its respective territorial jurisdictions, to this end, it shall ensure and support, among others, the promotion of its inhabitant's health and safety;

WHEREAS, further, pursuant to Section 457 (1) (iv) of the same Code, it is also mandated that the Sangguniang Panlungsod shall approve a resolution necessary for an efficient and effective city government, and in this connection, shall adopt measures to protect the inhabitants of the city from the harmful effects of manmade or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, this august Body is in receipt of 1st Endorsement dated October 18, 2019 from the Office of the City Mayor relative to the request to endorse the following properties as locations for the construction of evacuation centers:

1. Brgy. Gaas, NHA Housing Development, specifically on Lot 40, covered by Original Certificates of Title No. OP - 734 covered by Contract to Buy and Sell dated October 5, 2017 in favor of the Local Government Unit of Ormoc;
2. Brgy. Dolores, NHA Housing Development, specifically on Lot No. 7505 - A, covered by Transfer Certificate of Title No. 21620, covered by Deed of Absolute Sale dated October 11, 2018 in favor of the Local Government Unit of Ormoc; and
3. Brgy. Lake Danao, NHA Housing Development, specifically on a portion of Lot No. PSY - 137086 covered by Transfer Certificate of Title No. TH - 246, covered by a Contract to Sell dated May 30, 2019 in favor of the Local Government Unit of Ormoc.

WHEREAS, the endorsement of this august Body is one of the documentary requirements that will be submitted to the DPWH for the construction of the evacuation centers;

WHEREAS, the construction of evacuation centers are geared to step up the disaster risk reduction efforts and likewise strengthen this City's resilience;

WHEREAS, this City is determined to help and support all its local communities in their quest for better living through the implementation of various priority projects in response to the needs and concerns of the people;

WHEREAS, upon close and thorough review, this Sanggunian finds, that the requested favorable endorsement will further facilitate this City's resiliency efforts, and that the same is beneficial to the City, therefore, meriting this august Body's full support and favorable action;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Roiland H. Villasencio, Chairman, Committee on Public Properties, severally seconded by SP Members Tomas R. Serafica, Vicente L. Rama, Lalaine A. Marcos and Esteban V. Laurente; be it


