## RESOLUTION NO. 2019-119

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE ENTERED INTO BY AND AMONG THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), THE VISAYAS STATE UNIVERSITY (VSU) AND THE MATICA-A ORGANIC FARMER'S ASSOCIATION (MOFA) FOR THE IMPLEMENTATION OF CLIMATE SMART FARM BUSINESS SCHOOL (CSFBS) IN ORMOC CITY.

WHEREAS, the 15<sup>th</sup> Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on October 22, 2019 for consideration of a Memorandum of Agreement (MOA) to be entered into by and among the Local Government Unit of Ormoc City (LGU-ORMOC), the Visayas State University (VSU) and Matica-a Organic Farmers Association (MOFA) for the implementation of Climate Smart Farm Business School in Ormoc City, a copy of the final MOA is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the VSU is the zonal university in the Visayas whose academic, research and development, and extension functions are principally geared toward the development of rural communities through the empowerment of the farmers and fisherfolks;

WHEREAS, the VSU in collaboration with local government units and selected farmer associations is implementing the Climate-Smart Farm Business School which is a component of the program "Enhancing the Restoration of Farming Livelihoods in Yolanda-affected Areas in the Provinces of Leyte, Biliran and Samar thru SUC-led Extension, Research and Training Services";

WHEREAS, the LGU-ORMOC, is among the 38 selected local government units of Region VIII as beneficiary of the project Climate-Smart Farm Business School (CSFBS) which aims to promote entrepreneurship among farmer's association engaging into agricultural production;

WHEREAS, the MOFA is an LGU accredited farmer association taking part in the rehabilitation and recovery of lives and livelihood of its members through capacitating the association's skills on entrepreneurship with the infusion of climate-induced agricultural practices for an economically and sustainable farming enterprise;

WHEREAS, after review of the draft MOA by the City Legal Office, said office finds nothing legally objectionable thereto recommending that the draft MOA be endorsed to the Sangguniang Panlungsod for proper action, a copy of the letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, upon close and thorough review, this Sanggunian finds the aforementioned request by the City Mayor advantageous and for the best interest of the City and its inhabitants;

Simbajon; be it

The VISAYAS STATE UNIVERSITY, an institution of higher learning established under Pres. Decree No. 470 as amended by Pres. Decree No. 700, and converted into a state university by virtue of R.A. 9158 & 9437, with principal office at Visca, Baybay City, Leyte, duly represented by its University President, DR. EDGARDO E. TULIN, hereinafter referred to as "VSU";

The CITY OF ORMOC, a local government unit created by virtue of the laws of the Philippines, with the office address at New Ormoc City Hall, Brgy. Cogon, Combado, Ormoc City, represented herein by Mayor RICHARD I. GOMEZ, hereinafter referred to as "City of Ormoc";

The MATICA-A ORGANIC FARMERS ASSOCIATION, a people's organization formed to promote moral, social and economic well-being of all members, to develop a sustainable livelihood thru service and to work with non-government and government organizations or entities in the promotion and development of the association and in carrying out government policies, with address at Brgy. Matica-a, Ormoc City, duly represented herein by its President ROGELIO PEREZ JR., hereinafter referred to as "MOFA";

#### WITNESSETH

WHEREAS, the VSU is the zonal university in the Visayas whose academic, research and development, and extension functions are principally geared toward the development of rural communities through the empowerment of the farmers and fisherfolks, including members of the MOFA.

WHEREAS, the VSU conducted five-day Training of Trainers (TOT) to (1) one Agricultural Technologist and (1) one Local Farmer Technician of Ormoc City, Leyte.

WHEREAS, the City of Ormoc, is among the 38 selected municipalities of Region VIII as beneficiary of the project Climate-Smart Farm Business School (CSFBS) which then aims to promote entrepreneurship among farmer's association engaging into agricultural production.

WHEREAS, the City of Ormoc identified prospective recipients of the project in collaboration with the office of agriculture and its City Agriculturist (CA) or City Agriculture Officer (CAO).

WHEREAS, the City of Ormoc through City Agriculture Office assigned (1) one Agricultural Technologist and (1) one (Local Farmer Technician) to attend the five-day TOT and to serve as lead facilitators during the actual conduct of CSFBS community-based season long training.

WHEREAS, MOFA are farmers' associations with the following members, listed in Annex I respectively, taking part in the rehabilitation and recovery of lives and livelihoods of the members through capacitating the associations' skills on entrepreneurship with the infusion of climate-induced agricultural practices for an economically and sustainable farming enterprises.

NOW, THEREFORE, for and in consideration of the following premises and mutual covenants cited below VSU, CITY OF ORMOC, MOFA do hereby resolve as it is collaboratively work in the implementation of Climate-Smart Farm Business School which is a component of the program "Enhancing the Restoration of Farming Livelihoods in Yolanda-affected Areas in the Provinces of Leyte, Biliran and Samar Thru SUC-led Extension, Research and Training Services" do hereby commit the following.

### ARTICLE I RESPONSIBILITIES

## Section 1. Responsibilities of the Visayas State University

The VSU shall:

- 1.1 Assist the Agricultural Technician and Local Farmer Technician in the conduct of the three-month CSFBS community-based season long training.
- 1.2 Provide 2 copies of translated FBS manual, training supplies, incentives, meals and snacks throughout the sessions and intermediate trainings upon the start to completion of CSFBS community-based season long training.
- 1.3 Monitor the conduct of the CSFBS community-based season long training and provide appropriate counter measures to problems ahead.
- 1.4 Coordinate with the City of Ormoc as to the update and progress of the CSFBS community-based season long training.
- Organize graduation exercises at the end of the training to acknowledge the participation, effort and dedication of participants involved.

## Section 2. Responsibilities of City of Ormoc

The City of Ormoc shall:

- 3.1 Provide venue for the 12-day intermittent training conducive for learning and accessible to participants.
- 3.2 Assist VSU in monitoring the progress of the CFSBS community-based season long training.
- 3.3 Facilitate the access of transportation thru LGU from their respective areas to the training venue and vice versa.

## Section 2. Responsibilities of Matica-a Organic Farmers Association

#### The MOFA shall:

- 3.1 Commit active members of the association to attend the CSFBS community-based season long training.
- 3.2 Ensure that these representatives will commit to complete the attendance throughout the 12-day intermittent sessions of the three-month CSFBS community-based season long training.
- 3.4 Conduct re-echo of the learning gained from the season long training to the other members who are not participants of the CSFBS community-based season long training.

# ARTICLE II DURATION OF THE AGREEMENT

Section 1. This Agreement shall take effect upon its execution and shall be in full force and effect until December 31, 2019 for VSU.

# ARTICLE III TERMINATION

- Section 1. Failure of any party to comply and perform any of the terms and conditions of this Agreement shall give the other party the right to immediately terminate this Agreement by giving the defaulting party a written notice of such termination.
- Section 2. The parties may terminate the agreement anytime by mutual consent of the parties, provided that the sixty-day written notice by any of the parties shall have been served to the other.

## ARTICLE IV GENERAL PROVISIONS

- Section 1. This Agreement and all rights and obligations hereunder, shall not be assigned by either of the parties hereto to another party unless otherwise permitted in the provision of this Agreement or with the prior written thereto by the other parties.
- Section 2. This Agreement constitute the entire agreement between the parties relating to the subject matter hereof and there are no understanding, representations or warranties of any kind except those expressly set forth herein.
