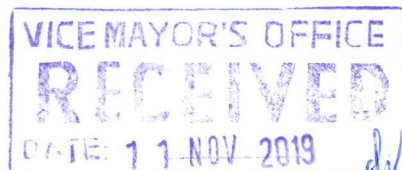
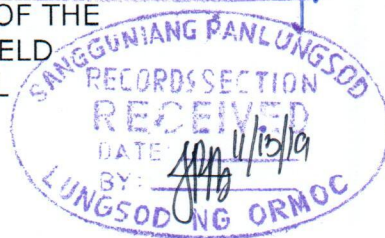

A RESOLUTION AUTHORIZING THE CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE TO APPROVE PROPOSED PROJECTS AND PROGRAMS FOR A SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2019 IN THE TOTAL AMOUNT OF FIFTY MILLION PHILIPPINE PESOS (PHP50,000,000.00) THEREBY ADOPTING CDC RESOLUTION NO. 11, SERIES OF 2019.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Endorsement dated October 23, 2019 from the City Mayor Richard I. Gomez forwarding the City Development Council (CDC) Resolution No. 11, SERIES OF 2019, entitled "A RESOLUTION AUTHORIZING THE CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE TO APPROVE PROPOSED PROJECTS AND PROGRAMS FOR A SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) IN THE TOTAL AMOUNT OF FIFTY MILLION PHILIPPINE PESOS (PHP50,000,000.00)";
