RESOLUTION NO. 2019-126

**A RESOLUTION AUTHORIZING THE HONORABLE CITY
MAYOR RICHARD I. GOMEZ TO UTILIZE THE
AMOUNT OF FIVE MILLION PHILIPPINE PESOS
(PHP5,000,000.00) TO BE TAKEN FROM THE TRUST
LIABILITIES - DISASTER RISK REDUCTION AND
MANAGEMENT FUND (QUICK RESPONSE FUND), AND
ALLOCATING SUCH FUND AS CASH ASSISTANCE OF
ONE MILLION PHILIPPINE PESOS (PHP
1,000,000.00) EACH TO THE FOLLOWING FIVE (5)
LGU'S DECLARED UNDER STATE OF CALAMITY AFTER
SERIES OF EARTHQUAKES IN MINDANAO, NAMELY:
THE CITY OF KIDAPAWAN, MUNICIPALITIES OF
TULUNAN AND MAKILALA IN THE PROVINCE OF
COTABATO AND MUNICIPALITIES OF BANSALAN
AND MATANAO, PROVINCE OF DAVAO DEL SUR.**

WHEREAS, powerful quakes shook Central Mindanao in less than three weeks last month: a magnitude 6.3 on Oct. 16, magnitude 6.6 on Oct. 29, and magnitude 6.5 on Oct. 31;

WHEREAS, the catastrophe resulted to many casualties and thousands of affected and displaced families, caused massive destruction to properties and damages to roads, bridges and flood control projects;

WHEREAS, according to the National Disaster Risk Reduction and Management Council (NDRRMC) Situation Report (SitRep #19) issued on October 31, 2019, Five (5) LGU's were declared under state of calamity due to substantial damaged cause by this series of earthquakes, namely: The City of Kidapawan, Municipalities of Tulunan and Makilala In The Province of Cotabato and Municipalities of Bansalan and Matanao, Province of Davao Del Sur;

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) of Ormoc City, issued Resolution No. 5, Series of 2019, entitled: "A Resolution to extend cash assistance of One Million Philippine Pesos each to the following Five Earthquake affected LGU's in Mindanao, namely: The City of Kidapawan, Municipalities of Tulunan and Makilala In The Province of Cotabato and Municipalities of Bansalan and Matanao, Province of Davao Del Sur";

WHEREAS, the office of the City Mayor through an Indorsement dated November 7, 2019, has forwarded to this Sanggunian a very urgent request for the issuance of a resolution authorizing the City Mayor to transfer the amount of Five Million Philippine Pesos (PHP 5,000,000.00) of the Local Disaster Risk Reduction and Management Fund of Ormoc, for assistance and support of disaster risk reduction work of the LDRRMC's in Mindanao that are severely affected by the series of earthquakes in October 2019;

WHEREAS, the City Accountant has issued certification that the sum of Five Million Philippine Pesos (PHP 5,000,000.00), is available from the Local Disaster Risk Reduction and Management Fund, which amount may be utilized as cash assistance to the LGU's devastated by the earthquake;

WHEREAS, the LGU of Ormoc, having gone through the same catastrophe during the November 8, 2013 Super Typhoon Yolanda and November 5, 1991 flashflood commiserate with the people in the affected places, as well as that of their respective LGU's ;

WHEREAS, the LGU of Ormoc, was also a recipient of various assistance from generous donors during the time when it was in dire situations and as a way of paying it forward manifested its desire to extend financial assistance to this affected LGU's;

WHEREAS, Section 1, Rule 18 of the Implementing of the Rules and Regulations of R.A. 1021 provides that "upon recommendation of the Local Disaster Risk Reduction and Management Office (LDRRMO) and approval of the Sanggunian concerned, the Local Disaster Risk Reduction and Management Council (LDRRMC) may transfer the said fund to support disaster risk reduction of other LDRRMO's which are declared under State of Calamity";

WHEREAS, Section 5(b) of the Rules and Regulations of R.A. 8185 states that: " A portion of the Calamity Fund may also be authorized to be used by the Local Government Units concerned, to provide financial assistance to other Local Government Units whose area or portion thereof have been declared under state of calamity by its Sanggunian";

WHEREFORE, on MASS MOTION of the Body; be it



RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR RICHARD I. GOMEZ TO UTILIZE THE AMOUNT OF FIVE MILLION PHILIPPINE PESOS (PHP 5,000,000.00) TO BE TAKEN FROM THE TRUST LIABILITIES - DISASTER RISK REDUCTION AND MANAGEMENT FUND (QUICK RESPONSE FUND), AND ALLOCATING SUCH FUND AS CASH ASSISTANCE OF ONE MILLION PHILIPPINE PESOS (PHP 1,000,000.00) EACH TO THE FOLLOWING FIVE (5) LGU'S DECLARED UNDER STATE OF CALAMITY AFTER SERIES OF EARTHQUAKES IN MINDANAO, NAMELY: THE CITY OF KIDAPAWAN, MUNICIPALITIES OF TULUNAN AND MAKILALA IN THE PROVINCE OF COTABATO AND MUNICIPALITIES OF BANSALAN AND MATANAO, PROVINCE OF DAVAO DEL SUR;
