RESOLUTION NO. 2019-138

A RESOLUTION ADOPTING CDC RESOLUTION NO. 7, SERIES OF 2019, ENTITLED, "A RESOLUTION CONFIRMING THE RECONSTITUTION AND FULL COMPOSITION OF THE CSO REPRESENTATIVES IN THE CITY DEVELOPMENT COUNCIL (CDC) SECTORAL COMMITTEE"

WHEREAS, under the implementing rules and regulations of the Local Government Code of 1991 (RA No. 7160) mandates local government units to promote the establishment and operations of people's organization, non-government organizations and the private sector, to make them active in the pursuit of local autonomy, and to directly involve them in the plans, programs, projects or activities in the local government units, such as, but not limited to, membership in the local special bodies;

WHEREAS, CLGOO-DILG Ormoc called for an assembly meeting of all accredited CSO's and elected among themselves, who become a member/s of the CDC;
