## RESOLUTION NO. 2019-147

AN OMNIBUS RESOLUTION APPROVING THE FOUR (4)
SEPARATE APPLICATIONS FOR ACCREDITATION
WITH THE LOCAL GOVERNMENT UNIT OF ORMOC,
IN ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF
THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS,
TO WIT:

- 1) MANLILINAO FARMERS ASSOCIATION (MAFA);
- 2) MAS-IN FARMERS ORGANIC RAINFED ASSOCIATION (MFORA);
- 3) UPPER COOB, LIBERTAD FARMERS ASSOCIATION (UPCOLFA); AND
- 4) GUINTIGUI-AN RAINFED RICE ACTIVE FARMERS ASSOCIATION (GRRAFA);

WHEREAS, it can be recalled that the 13<sup>th</sup> Sangguniang Panlungsod has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty – day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of four (4) separate applications for accreditation of the aforementioned civil society organizations;

WHEREAS, MAFA, duly registered with the Department of Labor and Employment (DOLE for brevity) on 23 March 2015, is an association of farmers which seeks to develop sustainable livelihood through the conduct of activities with the aim of uplifting the economic condition of its members, to this end, they undertake sweet potato, corn, peanut, turmeric and ginger plantation; it likewise acts as underwriter of crop insurance for its members;

WHEREAS, MFORA, duly registered with the DOLE on 4 May 2018, is an association of farmers which undertakes the promotion of moral, social and economic well-being of all its members, in furtherance thereof, it does roll-over scheme of the benefits they acquired from the High Yield Technology;

WHEREAS, UPCOLFA, duly registered with DOLE on 24 June 2016, is an association of farmers from Barangay Libertad, this City, working together to develop a sustainable livelihood through the conduct of activities with the end goal of uplifting the economic condition of its members;

WHEREAS, GRRAFA, duly registered with the DOLE on 28 August 2012, is an organization of farmers which seeks to provide its members with knowledge and skills and equip them with effective and innovative way of rice farming;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned four (4) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the applications to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Member, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Nolito M. Quilang, Vincent L. Rama, Gregorio G. Yrastorza III, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass AN OMNIBUS RESOLUTION APPROVING THE FOUR (4) SEPARATE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:

- 1) MANLILINAO FARMERS ASSOCIATION (MAFA);
- 2) MAS-IN FARMERS ORGANIC RAINFED ASSOCIATION (MFORA);
- 3) UPPER COOB, LIBERTAD FARMERS ASSOCIATION (UPCOLFA); AND
- 4) GUINTIGUI-AN RAINFED RICE ACTIVE FARMERS ASSOCIATION (GRRAFA);
