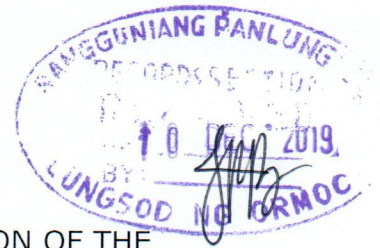

RESOLUTION NO. 2019-148

**AN OMNIBUS RESOLUTION APPROVING THE FIVE (5)
SEPARATE APPLICATIONS FOR RENEWAL OF
ACCREDITATION WITH THE LOCAL GOVERNMENT
UNIT OF ORMOC, IN ACCORDANCE WITH THE
PROVISIONS OF ORDINANCE NO. 009 DATED
OCTOBER 16, 2014 OF THE FOLLOWING CIVIL
SOCIETY ORGANIZATIONS, TO WIT:**

- 1) ORMOC CITY JACKFRUIT PRODUCERS
ASSOCIATION (OCJPA);**
- 2) UNIFARM MULTIPURPOSE COOPERATIVE
(Unifarm MPC);**
- 3) MARLIS FARMERS IRRIGATORS SERVICE
COOPERATIVE (MARLIS FISCO);**
- 4) KASANAG FARMER-IRRIGATORS MULTIPURPOSE
COOPERATIVE (KASANAG FIMPCO); AND**
- 5) REACT PHILIPPINES INC. OGMOK GROUP (REACT
OGMOK).**

WHEREAS, this august Body is in receipt of five (5) separate applications for renewal of accreditation of the aforementioned civil society organizations requesting for membership in the Local Special Bodies as provided for in Rule XIII of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, it can be recalled that the 13th Sangguniang Panlungsod has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty – day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, OCJPA, duly registered with the Department of Labor and Employment on 6 August 2012, is an organization which aims to provide its members with knowledge and skills and equip them with an effective and innovative way of jackfruit production, to this end, it trained its members how to plant trees with the use of organic fertilizers;

WHEREAS, Unifarm MPC, duly registered with the Cooperative Development Authority (CDA for brevity) on 7 March 2009, is a cooperative with the primary objective of undertaking lending, agricultural and industrial production, among others, it also buys and sells farm inputs, basic commodities, agricultural products, sugar and molasses trading, scientific sugarcane farming production and processing, health care services, and sorghum plantation;

WHEREAS, MARLIS FISCO, duly registered with CDA on 4 December 2009, is a cooperative which undertakes the operation and maintenance of service road, farm level irrigation and drainage facilities within the irrigated areas in the Bao River Irrigation System in accordance with the Turnover Agreement with the National Irrigation Administration;

WHEREAS, KASANAG FIMPCO, duly registered with CDA in April 2003, is a cooperative which undertakes irrigation, lending, marketing of agricultural farm inputs, crop protection, and post-harvest facilities to encourage and promote self-help or self-employment among its members as an engine for economic growth and poverty alleviation;

WHEREAS, REACT OGMOK, duly registered with the Securities and Exchange Commission on 23 June 1982, is an organization which aims to install among its members the high value of responsibility, sense of dedication and deep concern for the welfare of fellow Filipinos particularly the less fortunate or those who have less in life. In furtherance thereof, it imbues the spirit of discipline among members particularly in the observance and compliance of state laws and regulations;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned five (5) separate applications for renewal of accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the applications to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Member, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Nolito M. Quilang, Vincent L. Rama, Gregorio G. Yrastorza III and Joan Marbie C. Simbajon; be it
