RESOLUTION AMENDING THE TITLE OF THE PROJECT APPLICATION ATTACHED AS "ANNEX A" IN RESOLUTION NO. 2019-117 ENTITLED, "A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, OR THE ACTING CITY MAYOR, TO REPRESENT THE CITY IN THE APPLICATION FOR A PROJECT DEVELOPMENT AND MONITORING FACILITY (PDMF) MANAGED BY **PUBLIC-PRIVATE PARTNERSHIP** (PPP) **CENTER** RELATIVE TO **PROJECT** PREPARATION AND **TRANSACTION ADVISORY SERVICES FOR** THE IMPLEMENTATION OF PROJECTS THROUGH A PUBLIC-PRIVATE PARTNERSHIP AGREEMENT IN THE CITY AND TO DO ALL ACTS NECESSARY FOR THE SAME", FROM "LAKE DANAO BULK WATER SUPPLY PROJECT " TO "ORMOC CITY WATER SUPPLY SYSTEM PROJECT" WHICH SHOULD ALSO BE REFLECTED IN ALL OTHER DOCUMENTS INVOLVING THE SAME PROJECT TITLE, IN ORDER TO AVOID CONFUSION AS TO THE PROJECT SCOPE.

WHEREAS, the City through Resolution No. 2019-117 granted authority to the City Mayor Richard I. Gomez to represent the City in its application for a Project Development and Monitoring Facility (PDMF) managed by the PPPC relative to project preparation and transaction advisory services for the proposed Ormoc City Water Supply System which would address the existing insufficiency in the City's Water Supply;

WHEREAS, this august Body finds both resolutions in order but one involving the title of the project annexed in Resolution No. 2019-117, and in all other documents which the said title may be incorporated, which this Body wishes to address.

WHEREAS, the City recognizes the need to change the project title of the water supply system in the application the City submitted to the PDMF Committee last October 29, 2019, this is in order to avoid confusion as to the scope of the project;

WHEREAS, the project title, Lake Danao Bulk Water Supply Project, would eventually cause confusion as to the scope of the project to a bulk water supply only when the project would actually involve water sourcing, design and construction of facilities, and the operations and management of the entire water supply system;

WHEREAS, in order to avoid any confusion this august Body resolves to change the project title in its application and in all other documents involving the same from Lake Danao Bulk Water Supply Project to Ormoc City Water Supply System Project;

NOW THEREFORE, on motion of SP Member Nolito M. Quilang, Vice-Chairman, Committee on Laws & Ordinances, severally seconded by SP Members Vincent L. Rama, Gregorio G. Yrastorza III, Esteban V. Laurente and Joan Marbie C. Simbajon; be it
