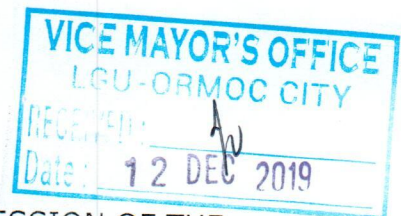

**RESOLUTION NO. 2019-165**

**A RESOLUTION COMMENDING THE ORMOC CITY  
ATHLETES AND THEIR COACHES FOR THEIR  
TRIUMPHANT CAMPAIGN IN THE 2019 SEA GAMES.**

WHEREAS, the 2019 Southeast Asian Games or the 30th Southeast Asian Games or 2019 SEA Games was held in the Philippines beginning November 30, 2019;

WHEREAS, one of the sports during the 2019 SEA Games is the Modern Pentathlon which comprised two (2) events, namely the Beach Laser Run and the Beach Triathlon;

WHEREAS, both events were held from December 4 to 7, 2019 at the Subic Bay Boardwalk Helipad, Subic Bay in the province of Zambales;

WHEREAS, the dual-discipline of Beach Laser Run combined Running and Shooting. This fast-paced and dynamic race comprise of four rounds of laser pistol shooting from 10-meter distance and four times of an 800-meter run. Athletes had to hit a target 5 times before proceeding to run. It conducted 3 medal events, to wit: Individual (Men), Individual (Women) and Mixed Relay;

WHEREAS, in the Beach Triathlon, another Modern Pentathlon sub-sport, athletes competed in a shoot-swim-run competition. In the Subic Boardwalk, the athletes started the race with a laser pistol shooting from 10-meter distance, followed by a 50m open water swimming, and then 800-meter run. The sequence is repeated 4 times. Athletes must hit a target 5 times before proceeding to run. It conducted 3 medal events, to wit: Individual (Men), Individual (Women) and Mixed Relay;



WHEREAS, the City of Ormoc fielded several athletes to the 2019 SEA Games, assisted by two (2) coaches who are based in Ormoc City;

WHEREAS, of the athletes from the City of Ormoc at the 2019 SEA Games, the following are the medalists *a. Samuel S. German- Silver for Beach Laser Run Individual Men, b. Samuel S. German and Princess Honey C. Arbilon- Gold for Beach Laser Run Mixed Relay, c. Michael Ver Anton A. Comaling- Gold for Beach Triathlon Individual Men, d. Princess Honey C. Arbilon, Bronze for Beach Triathlon Individual Women, and e. Michael Ver Anton A. Comaling and Princess Honey C. Arbilon, Bronze for Beach Triathlon Mixed Relay.* All displayed extraordinary and unyielding feats of endurance, accuracy and strength under the most grueling and challenging conditions by yielding medals in 5 of the 6 events;

WHEREAS, the athletes from Ormoc were coached and trained by Venerando "Coach Benny" D. Garcia as Head Coach and Rex De La Cruz as Assistant Coach, who forged and fostered with the use of their extensive knowledge and world class experience on the various disciplines among our athletes a culture of teamwork, perseverance and positivity;

NOW, THEREFORE, on MASS MOTION of the Body; be it


