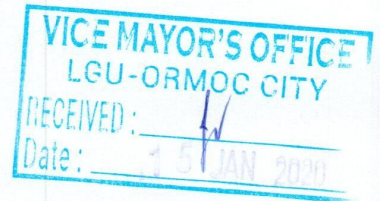


ADOPTED, January 14, 2020.
