RESOLUTION NO. 2020-013

A RESOLUTION FURTHER AMENDING ANNEX "B" OF SANGGUNIANG PANLUNGSOD NG ORMOC RESOLUTION 2019-001, NO. **ENTITLED**: RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15TH **SANGGUNIANG** PANLUNGSOD NG ORMOC".

WHEREAS, this Sanggunian passed a Resolution No. 2019-001, entitled: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15TH SANGGUNIANG PANLUNGSOD NG ORMOC" which specifically provided for, among others, the establishment and creation of the Twenty-five (25) Committees of the 15th Sangguniang Panlungsod, the composition of each standing committee is reflected in Annex "B" of said Internal Rules;

WHEREAS, on July 30, 2019 this Sanggunian passed Resolution No. 2019-016 amending among others, Annex "B" of the approved Internal Rules of the 15^{th} Sanggunian and provides for the new composition of certain standing Committees in order to render effective public service and governance to the constituents of the City of Ormoc;

WHEREAS, per amended Internal Rules under Annex "B" thereof, the Chairmanship of the Committee on Youth and Sports Development was granted to Ex-Officio SP Member Jasper C. Yerro. In addition thereto, SP Member Yerro was also granted membership to several standing committees as follows: Committee on Justice and Peace and Order; Committee on Health and Sanitation; Committee on Environment, Natural Resources and Energy Conservation; Committee on Education; Committee on Communication, Information Technology, and Public Information; and Committee on Employment, Livelihood & Manpower Development;

WHEREAS, SP Member Jasper C. Yerro had tendered his resignation and the same was accepted by the 15th Sanggunian on November 4, 2019 per SP Resolution No. 2019-118 thereby causing a vacancy on the Sanggunian Membership as well as in the Chairmanship and Membership of the standing committees enumerated above;

WHEREAS, considering the succession into office of a new Ex-Officio SP Member of the Sanggunian in the person of Joan Marbie S. Simbajon, it is deemed proper that the Chairmanship and Membership to the standing committees which became vacant due to resignation of former SP Member Yerro be likewise granted to her;

WHEREAS, the Body also finds it necessary to further amend and reorganize the compositions of the Committee on Environment, Natural Resources and Energy Conservation and Committee on Trade, Commerce & Industry for purposes of efficient supervision and administration of the City;

WHEREAS, a copy of the amended Annex "B" containing the new compositions of the affected committees of the Sanggunian is hereto attached and made an integral part of this resolution;

WHEREAS, the Internal Rules of Procedure adopted by this Sanggunian lays down the basis and procedure for its authority and power to fill up vacancies as well as to reorganize chairmanship, vice-chairmanship and membership in its regular committees thru a resolution specifically passed for such purpose;

Pongos, Jr., Chairman, Committee on Internal Rules of Procedure & Legislative Tracking, severally seconded by SP Members Tomas R. Serafica, Roiland H. Villasencio, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it
