## 10. PALOMPON TRANSPORT COOPERATIVE (PALTRANSCO)

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty – day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of ten (10) separate applications for accreditation of the aforementioned civil society organizations;

WHEREAS, KARANCHO, duly registered with the Securities and Exchange Commission (SEC for brevity) on 5 March 1997 is an organization of motorcycle riders and owners which believes that the restoration of the neglected cultural values can be strengthened, gearing towards Community Assistance and Development Program;

WHEREAS, SJSB – FIMPCO, duly registered with the CDA on 22 February 2010, is a cooperative which seeks, among others, to attain increased income, savings, investments, productivity and purchasing power as well as promote optimum social and economic benefits to its members;

WHEREAS, R.M. TUFA, duly registered with the Department of Labor and Employment (OCLE for previty) on 19 September 2014, is an association of farmers whose primary purpose is to engage in support services for irrigated agriculture such as provision of facilitation of credit, agriculture inputs, crop protection, post-harvest facilities and marketing in order to increase farmers' production and income;

WHEREAS, FGICI, duly registered with the SEC on 4 March 2018 organization of PNP force mobilizers that aims a stronger and more active brotherhood or sisterhood among their members with the Local Government Unit of Ormoc;

WHEREAS, BEFA, duly registered with the DOLE on 12 April 2018, is an association of farmers which seeks to equip its members with effective and innovative way in agricultural production through the conduct of trainings on how to apply and prepare organic fertilizer, the best ways to prepare seedlings before planting and like trainings;

WHEREAS, NWTF, duly registered with SEC on 6 March 1986, is an organization which seeks to promote the total human development of women, especially those from low-income and depressed urban and rural communities by providing Grameen-style microfinance as well as other development and social services;

WHEREAS, Coop for Christ – Leyte Multipurpose Cooperative, duly registered with CDA on 23 November 2009, is a cooperative which seeks to engage in credit and savings for both members and non-members, to this end it generates funds and extend credits for productive and provident purposes;

WHEREAS, Plan International Inc., duly registered with SEC on 9 July 2003, is an organization which strives for a just world, working together with children, young people, its supporters and partners to advance children's rights and equality for girls;

WHEREAS, OMTC and PALTRANSCO, duly registered with the CDA on19 March 2018 and 4 February 2010, respectively, are cooperatives composed of transport operators and holders of valid and subsisting Certificates of Public Convenience, who organized themselves in response to the government's Public Utility Vehicle Modernization Program and likewise to gain access to common resources, better fleet management system, efficient collection and ensure more effective franchise records management system;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned ten (10) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
