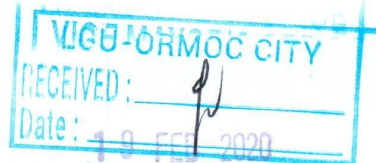

**RESOLUTION NO. 2020-052**

**AN OMNIBUS RESOLUTION APPROVING THE TEN (10)  
SEPARATE APPLICATIONS FOR ACCREDITATION  
WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN  
ACCORDANCE WITH THE PROVISIONS OF  
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF  
THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS,  
TO WIT:**

- 1) **LEYTE GEOTHERMAL EMPLOYEES MULTI-PURPOSE COOPERATIVE (LGEMC);**
- 2) **MARGEN AGRARIAN REFORM COOPERATIVE (MARCO);**
- 3) **PALINPINON FARMERS PRODUCERS COOPERATIVE (PFPC);**
- 4) **BOROC AGRICULTURAL PRIMARY MULTIPURPOSE COOPERATIVE (BAPMPC);**
- 5) **ORMOC SAVERS AGRICULTURE COOPERATIVE (OSACO);**
- 6) **CAMP DOWNES HOMEBASED WOMEN'S ASSOCIATION (CDHWA);**
- 7) **CAN-UNTOG FARMERS' ASSOCIATION (CANFA);**
- 8) **STO. NIÑO ORGANIC FARMERS ASSOCIATION (SNOFA);**

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty – day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of ten (10) separate applications for accreditation of the aforementioned civil society organizations;

WHEREAS, LGEMC, duly registered with the Cooperative Development Authority (CDA for brevity) on 17 February 2017, is a cooperative composed of geothermal employees cooperative which seeks to engage in credit and savings for its members, to this end it generates funds and extend credits for productive and provident purposes;

WHEREAS, MARCO, duly registered with the CDA on 14 February 2017, is a cooperative of farmer-beneficiaries of the Department of Agrarian Reform's Comprehensive Agrarian Reform Program which seeks to establish Black rice production to sustain the organic production of the cooperative;

WHEREAS, PFPC, duly registered with the CDA on 11 December 2005, is a cooperative which seeks to help improve the quality of life of its members and in furtherance thereto it aims to attain increase income, savings, investments, and promote among themselves equitable distribution of net surplus through maximum utilization of economies of scale, cost-sharing and risk-sharing;

WHEREAS, BAPMPC, duly registered with the CDA on 29 October 2009, is a cooperative which seeks to institutionalize a dynamic savings mobilization and capital build-up schemes to sustain its developmental activities and long-term investments, thereby ensuring optimum economic benefits to the members, their families and the general public;

WHEREAS, OSACO, duly registered with the CDA on 18 April 2018, is a cooperative which seeks to improve the living standards of its members through agricultural activities such as rice production, vegetable trading and other related activities;

WHEREAS, CDHWA, duly registered with the Department of Labor and Employment (DOLE for brevity) on 29 November 2018, is an organization of females which seeks to develop a sustainable livelihood through turmeric and squash noodles production that would help uplift the economic condition of the members;

WHEREAS, CANFA, duly registered with DOLE on 16 August 2018, is an organization of farmers which seeks to establish an association that will promote mutual aid and protection of its members;

WHEREAS, SNOFA, duly registered with DOLE on 7 September 2016, is an organization of farmers working together to develop a sustainable livelihood through the conduct of activities with the end goal of uplifting the economic condition of its members;



WHEREAS, OSDC, duly registered with the Securities and Exchange Commission on 15 January 2019, is an organization which advocates in marine environmental preservation and conservation in furtherance thereof it conducts clean-up drive and monitoring of coral reefs and sanctuaries;

WHEREAS, Ormoc City Retired Public School Teachers Association, Inc., duly registered with the SEC on 24 August 2018, is an organization of retired teachers which seeks to promote the rights and welfare of the retired teachers so as to alleviate poverty through delivery of social welfare services and program implementation;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned ten (10) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Tomas R. Serafica, Vice-Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Nolito M. Quilang, Peter M. Rodriguez, Vincent L. Rama, Lalaine A. Marcos, Esteban V. Laurente, Joan Marbie C. Simbajon and Jasper M. Lucero; be it
