A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR ACTING CITY MAYOR TO ENTER INTO AND SIGN THE DEED OF DONATION FOR AND IN SEMALF OF THE LOCAL GOVERNMENT UNIT OF CRMOC CITY (LGU-ORMOC), AS DONEE, WITH DEPARTMENT OF TRANSPORTATION, AS DONOR, OF A TWENTY FOOT (20-FT) REEFER CONTAINER VAN IDENTIFIED AS EQUIPMENT NUMBER MWCU5622717 TO BE USED IN SERVICE PROGRAMS AND OTHER LAWFUL PURPOSES.

WHEREAS, the 15<sup>TH</sup> Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on February 13, 2020 for consideration of the request for the issuance of a Resolution granting authority to the City Mayor to enter and sign a Deed of Donation to be entered into by and between the Local Government Unit of Ormoc City (DONEE) and Department of Transportation (DONOR) of a Twenty Foot (20-FT) Reefer Container Van Identified as Equipment Number MWCU5622717 to be used in service programs and other lawful purposes, a copy of the Deed of Donation is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the DONOR, pursuant to Executive Order No. 125-A, Series of 1987, as amended, is the primary policy planning, programming, coordinating, implementing, and administrative entity of the executive branch of the government on the promotion, development and regulation of a dependable and coordinated network of transportation systems, as well as in the fast, safe, efficient and reliable transportation services;

WHEREAS, the DONOR, pursuant to Executive Order No. 125-A, Series of 1987, has the power to establish and administer comprehensive and integrated program for transportation and communications, and for its purpose, may call on any agency corporation, or organization, whether public or private, whose development progress include transportation and communications, as an integral part thereof, to participate and assist in the preparation and implementation of such programs;

WHEREAS, the DONEE, pursuant to Section 22 and 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 (LGC), as a corporation have the power to acquire and convey real or personal property including negotiating or securing financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 of LGC, from local and foreign assistance agencies, upon authority of the Sangguniang Bayan/Panlungsod;

WHEREAS, the DONEE is in need of a reefer container for the use of its many service programs;

WHEREAS, this donation is being made in accordance with Section 776 of Presidential Decree No. 1445 (PD 1445) which states that any government property that is no longer serviceable or needed by the agency to which it belongs may be transferred without cost, or at an appraised value, to other agencies of the government upon the authority of the respective heads agencies in the national government, or of the governing bodies of government-owned and controlled corporations, other self-governing boards or commissions of the government, or of the local legislative bodies for local government units concerned;

WHEREAS, Section 5 of the General Provisions of Republic Act No. 10964, otherwise known as the General Appropriations Act for Fiscal Year 2019, provides that Departments, Bureaus and Offices of the national Government, including Constitutional Offices enjoying fiscal autonomy and SUCs may accept donations, contributions, grants, bequests or gifts, in cash or in kind, from various sources, domestic or foreign, for purposes relevant to their functions. Receipts from donations, whether in cash or in kind, shall be accounted for in the books of the donee-government agency in accordance with accounting and auditing rules and regulations;

WHEREAS, upon close and thorough review, this Sanggunian finds that the aforementioned Deed of Donation is advantageous and for the best interest of the City and its inhabitants therefore meriting this august Body's full support and favorable action;
