WHEREAS, Ordinance No. 026 series 2016 also known as the "Revised Ormoc City Investment Incentives Code of 2016" provides under Section 7 thereof that the Board shall be composed as follows:

f.) Two (2) Private Sector Representatives from the following major Investment Priority Areas, namely: 1) energy; 2) processing or manufacturing; 3) agricultural crop industry; 4) agricultural livestock, poultry and fisheries industry; and 5) academic institutions, with both representatives not belonging to a single area, to be appointed by the City Mayor for a term of two (2) years, and duly confirmed by the Sanggunian;

WHEREAS, the Ormoc City Investment Incentives Board is created to implement the provisions of the Ormoc City Investment Incentives Code and to supervise the operation of the Local Economic and Investment Promotions Center;

WHEREAS, there is a need to amend Executive Order No. 55 Series of 2019 and designate new members of the Ormoc City Investment Incentives Board due to changes in Committee memberships among members of the 15th Sangguniang Panlungsod and also changes in leadership among the various organizations in the City;

WHEREAS, Executive Order No. 10, Series of 2020, entitled "AN ORDER RECONSTITUTING THE COMPOSITION OF THE ORMOC CITY INVESTMENT INCENTIVES BOARD (OCIIB)" was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for confirmation of certain members as required under Ordinance No. 026, on February 19, 2020 and was referred to the Committee on Good Government and Committee on Trade, Commerce and Industry on February 24, 2020;
