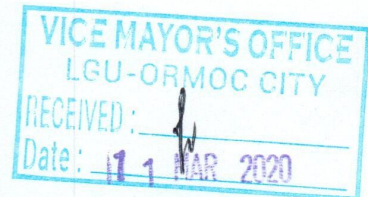

**AN OMNIBUS RESOLUTION APPROVING THE THREE (3)
SEPARATE APPLICATIONS FOR ACCREDITATION
WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF
THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS,
TO WIT:**

- 1. LAO SMALL FARMERS ASSOCIATION (LASFA);**
- 2. PIKAS LILOAN UNITED FARMERS ASSOCIATION (PLUFA); AND**
- 3. SIDLAK CHRISTIAN CHILDREN FUND SAVINGS AND CREDIT COOPERATIVE (SCCFSCC).**

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty - day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of Three (3) separate applications for accreditation of the aforementioned civil society organizations;

WHEREAS, LASFA, duly registered with the Department of Labor and Employment (DOLE for brevity) on 25 July 1996, is an organization of farmers seeking to implement planned thrift and savings program among its members by initiating fund raising activities in order to uplift the current situation of life of its members;

WHEREAS, PLUFA, duly registered with DOLE on 18 July 2017, is an organization of farmers that seeks to promote mutual aid and protection to its members through the conduct of trainings on value chain analysis and cassava grates orientation;

WHEREAS, SCCFSCC, duly registered with the Cooperative Development Authority on 16 November 2016, is a cooperative initiated and created by former beneficiaries of Christian Children Fund (CCF) – Redeemer Parent's Association Project and members of the Sidlak Youth Organization, Inc., that envisions itself to commit to help its members and the community in its financial management for social and economic growth;

WHEREAS, the call for accreditation of Civil Society Organizations was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned three (3) separate applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Roiland H. Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Vincent L. Rama, Nolito M. Quilang, Gregorio G. Yrastorza III, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass AN OMNIBUS RESOLUTION APPROVING THE THREE (3) SEPARATE APPLICATIONS FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:
