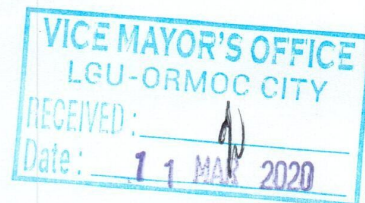

**A RESOLUTION ADOPTING THE ORMOC CITY TEN YEAR
ECOLOGICAL SOLID WASTE MANAGEMENT PLAN.**

WHEREAS, Republic Act 9003 (The Ecological Solid Waste Management Act of 2000) defines the role of the Local Government Units (LGUs) as "primarily responsible for the implementation and enforcement of the provisions of this Act within their respective jurisdictions;"

WHEREAS, RA 9003 further mandates the development by the LGUs of the "City xxx Solid Waste Management Plan that shall ensure the long-term management of solid waste, as well as integrate the various solid waste management plans and strategies of the barangays in its area of jurisdiction xxx;"

WHEREAS, the Local Government Code empowers the LGUs to discharge such "functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein, xxx including but not limited to (vi) Solid waste disposal system or environmental management system and services or facilities related to general hygiene and sanitation;

WHEREAS, the LGU Ormoc, through the City Solid Waste Management Board, has designed and issued the ORMOC CITY TEN YEAR SOLID WASTE MANAGEMENT PLAN that provides measures and practices towards sustainable and viable solid waste management collection and disposal, all while integrating the various solid waste management plans and strategies of its barangays;

WHEREAS, the ORMOC CITY TEN YEAR SOLID WASTE MANAGEMENT PLAN was presented to the NATIONAL SOLID WASTE MANAGEMENT COMMISSION by City Mayor Richard I. Gomez on February 20, 2020, a copy of the Plan is attached hereto and made an integral part hereof;

WHEREAS, the Commission found said SWM Plan consistent with the national framework and in accordance with the provisions of R.A. 9003, and of the policies set by the Commission, and approved thereof on even date;

WHEREAS, upon meticulous and careful consideration thereof, the ORMOC CITY TEN YEAR SOLID WASTE MANAGEMENT PLAN is found necessary for the achievement of an ecologically-balanced environment and is established to contain the mechanism that contains safeguards against pollution and for the preservation of the natural ecosystem as required by RA 9003 and applicable laws;

WHEREFORE, on motion of SP Member Lalaine A. Marcos, Chairman, Committee on Environment, Natural Resources & Energy Conservation, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Nolito M. Quilang, Eusebio Gerardo S. Penserga, Jasper M. Lucero, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Esteban V. Laurente and Joan Marbie C. Simbajon; be it


