A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I GOMEZ OR THE ACTING CITY MAYOR TO INTO AND SIGN THE **MEMORANDUM** AGREEMENT (MOA) TO BE ENTERED INTO BY AND BETWEEN THE ORMOC CITY GOVERNMENT AND PAYMAYA PHILIPPINES, INC. RELATIVE TO THE COLLECTION, TRANSMITTAL, AND REMITTANCE OF **FEES** AND PAYMENTS, AS WELL AS THE **ARRANGEMENT** DEPOSITING THE COLLECTED ORMOC CITY FEES AND OTHER PAYMENTS TO THE LANDBANK, ONLINE THROUGH ELECTRONIC MEANS.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated March 2, 2020 from the Office of the City Mayor, endorsing a request for the issuance of a resolution granting authority for the City Mayor to enter into and sign the Memorandum of Agreement (MOA) to be entered into by and between the Local Government Unit of Ormoc (LGU-Ormoc) and PAYMAYA PHILIPPINES, INC. relative to the collection, transmittal, and remittance of fees and payments, as well as the arrangement of depositing the collected Ormoc City fees and other payments to the LANDBANK, online or through electronic means, a copy of said MOA is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, in a Legal Opinion dated January 3, 2020, the City Legal Officer finds nothing objectionable to the terms of the Memorandum of Agreement and recommends that the same be referred to the Sangguniang Panlungsod for the issuance of a Resolution authorizing the City Mayor/OIC/Acting Mayor to sign the instrument, a copy of the Legal Opinion is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, PAYMAYA PHILIPPINES, INC. is a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines;

WHEREAS, Ormoc City, as a government agency, is covered by Republic Act No. 8792, also known as the "E-Commerce Act of 2000", and intends to continue adopting and enhancing its Remittance Verification Monitoring System (RVMS) for the processing and collection of loan amortizations and other fees;

WHEREAS, RA 11032 or the "Ease of Doing Business and Efficient Government Services Delivery Act of 2018", mandates all offices and agencies to improve their transactions systems and procedures;

WHEREAS, Ormoc City receives payment from housing loan amortizations, processing fees, and other charges from its clients;

WHEREAS, PAYMAYA offers PayMaya Payment Solutions (the "PPS");

WHEREAS, Ormoc City intends to avail of PAYMAYA'S PPS to accommodate payments of Ormoc City clients through PAYMAYA payments solutions,

WHEREAS, PAYMAYA is willing to extend provide its PPS and related services to the Ormoc City under the terms and conditions approved by all Parties;

WHEREAS, this Agreement covers the collection, transmittal, and remittance of Ormoc City fees and other payments, as well as the arrangement of depositing the collected Ormoc City fees and other payments to the LANDBANK;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggurian, after thorough examination of the aforementioned request by the City Mayor, finds that the same is entered into for the best interests of the City and its constituents:
