RESOLUTION NO. 2020-089

A RESOLUTION ADOPTING AND/OR CONCURRING WITH THE RECOMMENDATION OF THE ELECTRIC SUBSIDY COMMITTEE AS CONTAINED IN ITS MEMORANDUM REPORT ADDRESSED TO THE HONORABLE CITY MAYOR REGARDING THE UTILIZATION AND DISTRIBUTION OF ELECTRIC SUBSIDY.

WHEREAS, this Sanggunian received an indorsement from the Office of the City Mayor dated January 6, 2020, requesting for the august Body to concur with and/or adopt the findings and recommendations of the Electric Subsidy Committee;

WHEREAS, it will be recalled that the Electric Subsidy Committee of Ormoc City was created under Executive Order No. 59, Series of 2018, and tasked to come up with recommendations on the distribution of funds generated under Republic Act No. 9136, otherwise known as the Electric Power Industry Reforms Act of 2001;

WHEREAS, the aforementioned Electric Subsidy Committee submitted its Memorandum Report dated December 11, 2019 to the Honorable City Mayor, a copy of said Report is hereto attached and made an integral part hereof;

WHEREAS, there is an urgent need to pass and approve this resolution adopting and/or concurring with the recommendations of the Electric Subsidy Committee to facilitate and expedite the distribution of electric subsidy to all qualified consumers in Ormoc City especially given the adverse economic consequences of the COVID- 19 to most low income families and individuals;

WHEREAS, the immediate distribution of the subsidy will give much-needed relief to these qualified consumers given the present circumstances: states of Public Health Emergency (Proclamation No. 922) and Calamity (Proclamation No. 929), the imminent possibility of displacement from employment and lower business revenue due to the COVID- 19;

WHEREAS, the implementation and execution of the contents of the Memorandum Report are concerns well within the functions of the Executive Department through the Honorable City Mayor;

RECOMMENDATION ON THE UTILIZATION AND

DISTRIBUTION OF THE ELECTRIC SUBSIDY

This Memorandum Report is submitted in compliance with Executive Order (EO) No. 59, Series of 2018, creating the ELECTRIC SUBSIDY COMMITTIBEE (hereinafter referred to as the "Committee").

As contained in the mentioned issuance, the Committee was directed to perform the following functions:

- A. Evaluate and formulate plans for an effective and sustainable subsidy program for bona fide beneficiaries/consumers;
- B. Determine the class beneficiaries/ consumers who will benefit from the electrification subsidy program granted by the City Government in accordance with the provisions of the Local Government Code and R.A. No. 9513 otherwise known as the Renewable Energy Act of 2008,
- C. To monitor the implementation of the electrification subsidy program and ensure that its desired results and benefits are attained;
- D. To conduct periodic review of the program and recommend changes, if necessary, in order to improve the same and maximize the benefits that could be enjoyed by its beneficiaries/consumers; and,
- E. To submit reports and/or recommendations to the Office of the City Mayor, where needed.

The Committee convened and met on the following dates:

- A. January 22, 2019;
- B. December 16, 2019;

After the deliberations made by the Committee on the aforementioned dates, the following points have been established and agreed upon by the members:

FIRST, the subsidy covers the total of four (4) years, pertaining to the years 2015 to 2018;

SECOND, the amount available for distribution as direct subsidy is in the aggregate of Pesos: Thirty Million Six Hundred Ninety Nine Thousand Forty Pesos and Sixty Four Centavos (30,699,040.64 Php), as certified to by Assistant City Treasurer Alicia C. Dimapingun (Office-in-Charge of the City Treasurer's Office (ICO-CTO)), as follows:

THIRD, the electric consumers qualified to receive the subsidy are those whose monthly consumption in a residence does not exceed One Hundred Kilowatt Hours (100 kWh) as expressed in Republic Act No. 9513, otherwise known as the Renewable Energy Law (RE Law) and Section 21.B of the Implementing Rules and Regulations of the RE Law clearly which specifies, that: "... eighty percent (80%) of the share of the royalty and/or government share of the RE host community / LGU from RE projects and activities shall be used directly to subsidize the electric consumption of end-users in the RE host communities / LGUs whose monthly consumption do not exceed one hundred kilowatt hours (100 kWh)."

FOURTH, the total number of qualified consumers and accounts as determined by LEYECO V is One Hundred Thirty Three Thousand Four Hundred Eighty Six (133,486).

FITH, the electric subsidy will be paid on a per-qualified-account basis, I.e., to all One Hundred Thirty Three Thousand Four Hundred Eighty Six (133,486) accounts. Therefore, there may be consumers who will receive more than one amount or subsidy, if his or her account(s) all meet the criterion of consuming 100 kWh or below;

SIXTH, the amount of the subsidy to be given to each qualified account shall be based on his/her monthly consumption;

SEVENTH, the amount of the subsidy to be distributed shall be computed as follows:

Initially, we compute the amount of subsidy per KwH for a particular year.

Let, x = the amount of subsidy per kWh of a particular year.

y =the total fund (share) for a particular year.

(80% share including interest, see table on page 4)

z = the total number of kWh consumed by all qualified accounts of a particular year.

We then compute the amount of subsidy per month for each of the qualified accounts for a particular year.

Let, a = the amount of subsidy per month of a particular account for a particular year.

b = the number of kWh consumed by a qualified account for a particular month of a particular year.

x = the amount of subsidy per kWh of a particular year.

a is derived as the product of b and x, thus

a(2015) = b(2015) x(2015)

To get the total amount of subsidy of a qualified account for a particular year is to multiply a by the number of months that qualified account did not exceed 100kWh consumption;

EXCEPTN, the list of qualified beneficiaries and the amount to be received by each are shown in the ledger per Barangay/Year, copy is on file with the City Treasurer's Office.

NINTH. The lists will be distributed to the Barangay Captains for posting in conspicuous places in their respective Barangay Halls;

TENTH, Ms. Dimapingun, as Local Treasury Operations Officer IV, will be charged with the proper distribution of the subsidy;

ELEVENTH, the amount of subsidy will be released directly to the consumer whose name is registered as an account. In his/ her absence/ incapacity/ disability/ death, the claimant must present his/her authority/ interest to claim the amount pertaining to the account holder. The following documents are required to be presented in the distribution:

IF THE CLAIMANT IS THE ACCOUNT HOLDER:

a. Valid and existing government issued ID bearing the name, signature and image of the account holder, i.e.: SSS/PRC/Driver's License/Postal ID. The name appearing on the ID must be the same as that registered as an account name with the LEYECO records; If the account holder has no government issued ID, a Barangay Certification where he/she is a resident attesting to his/her identify, must be presented for the purpose of claiming the electric subsidy.

IF THE CLAIMANT IS NOT THE ACCOUNT HOLDER:

a. Special Power of Attorney/ Partition/ Settlement/ Adjudication/ Waiver or Assignment or any instrument showing his/ her interest(s) on the amount; AND

b. Valid and existing government issued ID bearing the name, signature and image of the claimant i.e.: SSS/PRC/Driver's License/Postal ID. The name appearing on the ID must be the same as that stated in the document in the immediately preceding paragraph. If the claimant has no government issued ID, a Barangay Certification where he/ she is a resident attesting to his/ her identify, must be presented for the purpose of claiming the electric subsidy.

The above enumerated points that were agreed upon by the Committee shall constitute its recommendation to the Honorable City Mayor in the utilization and distribution of the electric subsidy for the years 2015 to 2018;
