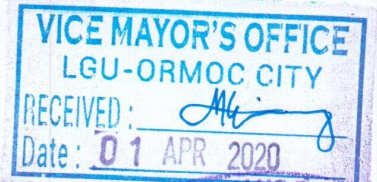

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received copies of Ordinances from the above enumerated Barangays, all entitled: "AN ORDINANCE AUTHORIZING THE CITY OF ORMOC TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER". The copies of the Ordinances together with its attachments are hereto attached and made an integral part hereof;

WHEREAS, the ordinances were submitted to this Sanggunian pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Section 57 and 458 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" (LGC) in order to find out whether the subject Ordinances approved by the respective Sangguniang Barangays are within the scope of its prescribed powers and also whether the same are in conformity with law and city ordinances;

WHEREAS, the enactment of the subject barangay ordinances by the concerned barangays is pursuant to EODB ACT of 2018 or Republic Act 11032, otherwise known as "An act Promoting Ease of Business and Efficient Delivery of Government Services, amending for the purpose of Republic Act No. 3485";

WHEREAS, Section 11 (f) of the above-mentioned Republic Act duly amended the Section 152 (c) of the Local Government Code and provides that "Barangay Clearances and Permits related to doing business shall be applied, issued and collected at the City/Municipality in accordance with the prescribed processing time of the said act. Provided, that the share in the collection shall be remitted to respective Barangays;

WHEREAS, this Sanggunian, in the exercise of its review powers, and after thorough examination of the aforesaid Barangay Ordinances, finds that the same were enacted for the purpose of raising revenues for the Barangay, which will in turn be utilized to deliver basic services and promote the general welfare and convenience of the Barangay constituents;

WHEREAS, this Sanggunian, finally finds that the Ordinances are valid and lawful and within the scope and authority of the Barangays, and therefore, manifests herein no objections to its implementation, and even urges that they be implemented immediately in order to speedily further the noble ends they seek for welfare of the Barangays;



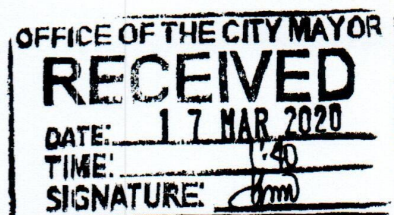

BARANGAY ORDINANCE No. 2020-01

AN ORDINANCE AUTHORIZING THE CITY/MUNICIPALITY OF ORMOC TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER

WHEREAS, under Section 152 (c) of the Local Government Code states that:

"Barangay Clearance – No city or municipality may issue any license or permit for any business or activity unless a clearance is first obtained from the barangay where such business or activity is located or conducted. For such clearance, the Sangguniang Barangay may impose a reasonable fee. The application for clearance shall be acted upon within seven (7) working days from the filing thereof. In the event that the clearance is not issued within the said period, the city or municipality may issue the said license or permit."

WHEREAS, the EODB ACT of 2018 or Republic Act 11032, otherwise known as "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Service, Amending for the Purpose of Republic Act No. 9485" was duly enacted;

WHEREAS, Section 11(f) of the above-mentioned Republic Act duly amended the Section 152 (c) of the Local Government Code, and provides that "Barangay Clearances and Permits related to doing business shall be applied, issued and collected at the City/Municipality in accordance with the prescribed processing time of said Act. Provided, that the share in the collection shall be remitted to respective barangays; and

WHEREAS, Barangay Cabingtan, in accordance with the above provisions, and as an implementation of "one stop shop", hereby authorizes the City/municipality of ORMOC to issue Barangay Clearance and collect corresponding barangay clearance fee in the application for any business related transactions subject to the remittance of the aforesaid fees to the barangay and the conditions hereunder.

NOW THEREFORE, be it ORDAINED as it is hereby ORDAINED by the Barangay Council of Barangay Cabingtan in a session duly assembled the following:

SECTION 1.Coverage. This Policy applies only to the issuance of barangay Clearance for Business Permit and location clearance (as a requirement for the issuance of building permit) at the City/Municipality. Other Clearances for other purposes shall still be obtained at the Barangay.

This Circular shall cover all City and Municipal Mayors, Punong Barangays, Concerned Local Officials, DILG Regional Directors and BARMM Minister of Local Government and all others concerned.

SECTION 2. Definition of Terms. The words and phrases used in this ordinance are hereby defined as follows:

Barangay Clearance – refers to any and all documents issued by the barangays with or without corresponding fees as defined in their relative to or in relation to the issuance of business permit and location/zoning clearance by the city/municipality or any other permit as may be required. (IRR of RA 11032)

Barangay Clearance Fees – is an amount imposed by the barangay through an ordinance and collected by the city/municipality in relation to the issuance of business permit and location/zoning clearance by the city/municipality.

Business Permit – is a document that must be secured from the city/municipal government usually through its Business Permits and Licensing Office (BPLO), for Business to legally operate in in the locality. (IRR of RA 11032)

Locational Clearance – is a clearance issued by the Zoning Administrator/ Zoning Officer to a project that is allowed under the provision of an ordinance of a particular City/Municipality. It is a requirement for the issuance of Building Permit. (House and Land Use Regulatory Board in Comprehensive Land Use Plan Guidebook)

SECTION 3. Authority to collect Barangay Clearance Fee of Business Related Transactions – The City/Municipality of ORMOC is given the authority to collect Barangay Clearance Fee subject to the remittance to the subject barangay.

SECTION 4. Rate of Barangay Clearance Fee to be Collected – The rate of Barangay Clearance Fee to be collected by the City/Municipality for the issuance clearance shall be computed in accordance with the subject Barangay Revenue Ordinance herein attached as "Annex A", and made as an integral part hereof.

SECTION 5. Barangay Clearance Signatory – Electronic Signature of Punong Barangay concern shall appear in all Barangay Clearance issued.

SECTION 6. Reporting and Remittance – The City/Municipality shall remit the Barangay Clearance Fee collected to the subject barangay not later than Seven (7) working days of the ensuing month with the list of the issued Building and Business Permit.


SECTION 7. Separability Clause – If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.


SECTION 8. Repealing Clause – All provision Ordinance and Rules/Regulation which are inconsistent with the provisions of this Ordinance are hereby deemed, modified or repealed accordingly.

SECTION 9. Effectivity Clause – This Ordinance shall take effect fifteen (15) days after its publication.

AN ORDINANCE AUTHORIZING THE CITY/MUNICIPALITY OF ORMOC TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER

WHEREAS, under section 152© of the government code states that:

"(c) Barangay Clearance-No City Municipality may issue any license or permit for any business or activity unless a clearance is first obtained from the Barangay where such business or activity is located or conduct. For such clearance, the sangguniang Barangay may impose a responsible fee. The application for clearance shall be acted upon with (7) working days from the filing thereof. In the event that the clearance is best issued within the said period, the City or municipality may issue the said license or permit.

WHEREAS, the EOBD ACT of 2018 or Republic ACT 11032, otherwise known as "An act Promoting Ease of doing Business and efficient Delivery of Government Service, Amending for the purpose of Republic Act No.9485 " was duly enacted.

WHEREAS, Section 11(f) of the above-mentioned republic act duly amended the section 152© of the local government code, and provides that Barangay clearance and permits related doing business shall be applied, issued and collected at the city/municipality in accordance with the prescribed processing time of said act. Provide that the share in the collection shall be remitted to respective Barangay; and

WHEREAS, Barangay LEONDONI, in accordance with the above provisions and as an implementation of "one stop shop" hereby authorize the City/Municipality of Ormoc. To Issue Barangay Clearance and collect corresponding Barangay clearance fee in the application for any business related transaction subject to the remittance of the aforesaid fees to the Barangay and the conditions hereunder.

SECTION 1. Coverage. This policy applies only to the issuance of Barangay clearance for business permit and locational clearance (as a requirement for the issuance of building permit) at the City/municipality. Other clearances for the purposes shall still be obtained at the Barangay.

SECTION 3. 3. Authority to collect Barangay clearance fees of Business Related transaction-The City/Municipality of Ormoc is given the authority to collect Barangay Clearance fee subject to the remittance to the subject Barangay.

SECTION 4. Rate of Barangay Clearance fee to be collected-the rate of Barangay Clearance fee to be collected by the City/municipality for the issuance clearance shall be computed in accordance with the subject Barangay revenue ordinance herein attached as "Annex A" and made as an integral part hereof.

SECTION 5. Barangay Clearance Signatory-Electronics Signature of Punong Barangay concerned shall in all Barangay clearance issued.

SECTION 6. Reporting and Remittances-The City/Municipality shall remit the Barangay Clearance Fee collected to the subject Barangay not later than (7) working days of the ensuring month with the list of the issued building and Business Permit.

SECTION 7. Separability Clause-if for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provision hereof which are not affected thereby shall remain valid and in full force and effect.

SECTION 8. Repealing Clause-All previous Ordinance and rules/regulations which are inconsistent with the provisions of this ordinance are hereby deemed, modified or repealed accordingly.


SECTION 9. Effectivity Clause-This ordinance shall take effect fifteen (15) days after its publication.




