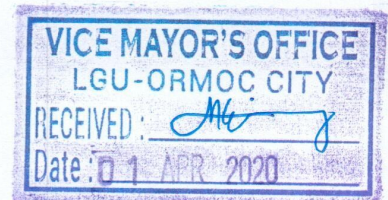

**RESOLUTION NO. 2020-101**

**A RESOLUTION APPROVING THE APPLICATION FOR  
ACCREDITATION WITH THE LOCAL GOVERNMENT  
UNIT OF ORMOC, IN ACCORDANCE WITH THE  
PROVISIONS OF ORDINANCE NO. 009 DATED  
OCTOBER 16, 2014 OF THE KASAMMAVA FARMER-  
IRRIGATORS SERVICE COOPERATIVE (KASAMMAVA  
FISCO).**

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty - day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of an application for accreditation of the aforementioned CSO;

WHEREAS, KASAMMAVA FISCO, duly registered with the Cooperative Development Authority on 9 November 2009, is a cooperative which seeks to engage in palay trading, rice milling, production of crops, vegetables and animals, further, it seeks to process and market the members' produce by providing allied services such as storage and transport of the products and lending operations for the agricultural production of members;

WHEREAS, the call for accreditation of CSOs was caused by the Fifteenth Sangguniang Panlungsod in accordance with the provisions of Ordinance No. 009 dated 16 October 2014 which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, this Sanggunian, after thorough review of the aforementioned application for accreditation, finds that the same is in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the local government unit in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Tomas R. Serafica, Nolito M. Quilang, Esteban V. 
